## 1 APOLOGIES FOR ABSENCE

There were no apologies for absence.

## 2 CONFIRMATION OF MINUTES

Cllr Davidson proposed, Cllr Mrs Moyle seconded (Cllr Boase, Cllr Clayton and Cllr Mrs Swift who were absent from the last meeting abstained) all others in favour that the minutes of the Ordinary Parish Council Meeting held on Monday December 15, 2008 are a true record and the Chairman signed them as such.

# 3 MATTERS ARISING AND NOT COVERED ELSEWHERE IN THIS AGENDA

There were no matters arising which were not covered elsewhere in the agenda.

# 4 COUNTY AND DISTRICT COUNCILLORS' COMMENTS

CCCllr Phillips reported that

- he was delighted to be in a position to recommend a grant of £1,000 from the Members' Community
  Grant Scheme towards the publication of *Five Walks in Wendron* and understood that the Clerk had
  received notification of this award
- as a member of the public, he had noticed that, at the Farms Common bend, the red warning sign does not reflect and that some of the reflective bollards are missing.

In answer to a question, CCCllr Phillips said that, although he keeps pressing for construction of the relief road at Trewennack he does not believe it will be brought forward under the new public works initiative.

KDCllr Mrs Taylor reported that a survey on local authority office space has revealed that County Hall has sufficient room to employ 1,100 people. This is a sizable increase on the number employed there at present and raises questions about sustainability in towns and villages other than Truro should employee numbers at County Hall be increased.

KDCllr Mrs Swift reported that, as the Chair of Kerrier's Audit Committee, she had recently attended an extended Finance Meeting at County Hall at which the new Unitary Authority Directors had pleaded the case for keeping their budgets at present levels. The ultimate aim is to have a seamless transfer financially from the County Council to the Unitary Authority. On another note, she reported that Citizens' Advice Bureaux throughout Cornwall have now been merged into CAB Cornwall of which she is a Board Member.

KDCllr Clayton reported that

- CCCllr Whalley has advised the Joint Implementation Executive that the Boundary Committee will complete their review to enable the election to take place on October 22, 2009
- the Environment Agency and the applicant's agent have reached mutual agreement for a main line sewer connection at The Old Vicarage, Penmarth to be installed by the end of January
- work on the main line sewer scheme in Carnkie will commence shortly; Building Regulation costings have been given to Mr Len Pascoe for distribution. The inspection fee for works under £1,000 is £50.00; above that the fee is £100.00
- at Kerrier, a funding increase to the existing budget for Community Projects will be considered at the Kerrier District Council Cabinet meeting on February 3, 2009. It is intended that this will help to fast-track funding for a variety of projects throughout the District
- the £1,500 agreed funding for road signage at Farms Common will be transferred to Wendron Parish Council in the near future
- in the interim period, Kerrier District Council and Penwith District Council will each have six Members (politically balanced) on the Area Planning Committees. This will have the effect of denying all local representation
- the Parish and Town Council precepts 2009/10 will be subject to capping; a report will be going to the Implementation Executive on January 22, 2009 giving details
- Planning Enforcement procedures are being followed at The Old Carpenter's Shop, Laity.

## **6 PUBLIC PARTICIPATION**

Wishing everyone present a very happy New Year, Mr Perry said that he believes it important that the Parish Council continues to pressurize Cornwall Highways to complete the relief road at Trewennack.

Speaking as the Chairman of Crowan Parish Council, Mrs Taylor spoke of her Council's dismay that the Boundary Committee's draft recommendation splits her Parish into two wards. She spoke of the fears both for the historic boundaries of the Parish and of the consequent loss of identity. Her Council has proposed that Crowan joins Wendron in a single Unitary Authority ward and she asked for Wendron Parish Council's support in this proposal. Answering, the Chairman, Cllr Mrs Warren, said that Wendron has already replied to the Boundary Commission stating that the Parish is happy with the draft recommendation.

## OTHER MATTERS

The Clerk was asked to write to Mr Colin Jarvis (CCC Acting Director Planning, Transportation and Estates) both to express concerns (in the light of the present economic climate) about possible delays with the provision of the relief road at Trewennack and (following a report from Cllr Mrs Lay) to draw attention to problems relating to parking outside Wendron School.

Cllr Clayton drew members' attention to debts incurred by Cornwall County Council which have risen from £120 million four years ago to a present total of £585 million (a debt which costs residents of Cornwall £25 million per annum to service). He further warned of a proposal to collect both recylates and household rubbish on a monthly basis.

Cllr Mrs Lay drew members' attention to signage elsewhere in the county which details numbers of accidents on a particular stretch of road and suggested that such a sign might be erected at or near Farms Common.
