Minutes of the Annual Meeting of Wendron Parish Council held on Monday May 11, 2009 following the Annual Parish Meeting in the Community Hall, Burras.

Welcoming members and visitors to the meeting, the Chairman introduced Mr Colin Garrick from the West Cornwall and Isles of Scilly Rural Transport Partnership.

Mr Garrick said that the Rural Transport Partnership has been in existence for a number of years and has assisted in some thirty projects, in particular the Wheels to Work scheme, improvements to the bus service in the East Lizard and West Cornwall Community Wheels (which operates from Hayle and is more popularly known as Dial-a-Ride). The remit of the partnership is to improve access to employment, to health services, to leisure activities and to shops.

At the moment (because of the advent of the Unitary Authority) the partnership appears to be in limbo, but he is nevertheless keen to establish links with Parish Councils and, in future, with the new Community Networks. He anticipates development along the lines of the existing Penwith Rural Transport Forum which draws member representatives from many different organisations as well as from the public transport companies, including First Great Western.

There appears to be a need for people living in the parish to travel to Camborne and Redruth, but access by public transport is, at best, uncertain and unquestionably does not supply the varied demands. There are two obvious ways forward: dial-a-ride minibuses and voluntary/community car schemes. Capital expenditure for the former is a problem and the cost per mile for the recipient of the latter may be prohibitive.

Following discussion, members asked Mr Garrick to send the Council a written summary of the way in which a working scheme is operating with a view to exploring how it might be adapted for residents of the parish of Wendron.

On behalf of members, the Chairman thanked Mr Garrick for attending.

1 ELECTION OF CHAIRMAN

PC Dave Vaughan introduced PCSO Ceri Sadler to members, adding that she has recently finished training and has now started work in the Parish.

He reported that, in April there had been five crimes reported to the Police: possession of cannabis, theft from a motor vehicle, theft of a mobile phone, a burglary and criminal damage to a motor vehicle. This compares with four reported crimes in April of last year.

It has also been reported that in Carnkie a number of youngsters are riding mini-motos without the protection of helmets and PC Vaughan asked for help in contacting them.

14 PROJECTS WITHIN THE PARISH

Wendron Walks booklets – It was agreed that the Chairman would distribute a copy of the booklet to each of the pupils at Wendron School on Thursday May 21 and at Halwin School on Friday May 22. The Clerk reported that the concerns raised at the last meeting simply mean that, if the booklet is sold through retail outlets then detailed accounts will have to be kept. He was asked to write a document outlining the requirements of marketing the booklets.

Clearance of scrub from around the hut circles on Calvadnack Hill – The Clerk reported that grant funding both to clear the scrub and to provide interpretation boards is available from Natural England through Cornwall Council. Concerns were expressed about future maintenance costs and the Clerk was asked to speak to Tom Fletcher at Cornwall about the matter and to report back to the next meeting

Provision of a Community Bus/Dial-a-Ride scheme – It was agreed that Mr Garrick's talk had been useful, but concerns were expressed about the suitability of such a scheme for the Parish of Wendron. Nevertheless, members agreed to await a written description of an operational scheme before coming to any decision.

Provision of a footpath from Trelill to Trewennack – It was agreed that this idea is impracticable, not least because the existing line of the road means there is no available land on which to build a path.
