Minutes of the Ordinary Meeting of Wendron Parish Council held on Monday, June 8, 2009 at 7:30pm in the Community Hall, Burras.

The Chairman welcomed Members and visitors to the meeting.

1 APOLOGIES FOR ABSENCE

Cllr Mrs Moyle, Cllr Mrs Lackner and Cllr Mrs Swift sent their apologies for absence.

2 CONFIRMATION OF MINUTES

Cllr Mrs Warren proposed, Cllr Mrs Mitchell seconded, (Cllr Buxton and Cllr Davidson, who were absent from the last meeting, abstained) all others in favour that the minutes of the Annual Parish Meeting held on Thursday May 11, 2009 are a true record and the Chairman signed them as being accurate.

Cllr Clayton proposed, Cllr Mrs Warren seconded (Cllr Buxton and Cllr Davidson, who were absent from the last meeting, abstained) all others in favour that the minutes of the Annual Meeting held on Monday May 11, 2009 are a true record and the Chairman signed them as such.

Cllr Mrs Lay entered the room.

3 MATTERS ARISING AND NOT COVERED ELSEWHERE IN THIS AGENDA

There were no matters arising which were not covered in this agenda.

4 COUNTY COUNCILLOR'S COMMENTS

The Chairman congratulated Cllr Clayton on his success in the recent Cornwall Council elections.

Offering his thanks to those who had supported him in the election, Cornwall Councillor Clayton said that he would do his best to represent everyone who lives within the ward. He warned that, as the County Councillor, he represents three parishes and must act impartially and that he therefore intends to take a less active role on Wendron Parish Council. He spoke of radical changes in local government and of the consequent opportunities for Parish Councils to take greater responsibility for the delivery of local services previously undertaken by District and County Councils. In particular he urged members to participate actively in the Community Network by sending a representative to meetings. In this respect he saw his role as being a facilitator between the Parishes and the County. Concluding, he spoke of his respect for all those who had stood for election, stating that it had been an exhausting few weeks.

5 POLICE REPORT

Through the Clerk, PC Vaughan reported that in May 2009 five crimes were reported to the police (an assault, a burglary and three thefts), which compares with a similar figure reported during the same period in

2008. He reminded Councillors and Parishioners alike of the need to be vigilant in securing properties and to take extra care when leaving vehicles unattended.

6 PUBLIC PARTICIPATION

Ms Weston said that she had been delighted to learn of the publication of *Five Walks around Wendron* which, she added, will enable members of the public to enjoy the history, the countryside and the footpaths of the Parish.

7 PROJECTS WITHIN THE PARISH

Wendron Walks booklets – members considered a discussion document prepared by the Clerk concerning the distribution of the booklets. Cllr Hamilton proposed and it was agreed to accept this document with minor additions and a copy including those revisions is attached to these minutes.

Clearance of scrub from around the hut circles on Calvadnack Hill – the Clerk reported that, as requested, he has spoken to Tom Fletcher from Cornwall Council (who is responsible for Cornwall's application for capital works funding from Natural England) and that he intended raising the question of ongoing maintenance following capital works at a meeting with Natural England's representative this coming Thursday. As a result of an invitation to join a site meeting on Calvadnack Hill it was agreed that Cllr Mrs Warren and Cllr Mrs Lay will represent Wendron Parish Council.

Provision of a Community Bus/Dial-a-Ride scheme – the Clerk reported that Colin Garrick from the West Cornwall and Isles of Scilly Rural Transport Partnership is on annual leave and that no written scheme for consideration by members has been received.

8 FINANCE

As a Governor of Halwin School, Cllr Clayton declared a personal interest in the following application for financial help. He remained in the room but took no part in the discussion or the voting.

Members considered a request from Halwin School for financial help towards the purchase of staging. Following discussion, Cllr Davidson proposed, Cllr Mrs Warren seconded all in favour that under the terms of S137 of the Local Government Act 1972 Wendron Parish Council should donate £1,000.00 towards this project once an indication that the staging has been received and an invoice has been received.

PA09/00626/F Mrs C Tremayne – Erection of two-storey extension to dwelling – Halabezack Farm, Polhigey. Cllr Hamilton proposed, Cllr Mrs Warren seconded and it was agreed that Wendron Parish Councillors support this application.

PA09/00635/F Mr & Mrs M Stairmand – Erection of a two storey extension to dwelling – 2 Wheal Oak, Trenethick Fields, Helston. Cllr Hamilton proposed, Cllr Davidson seconded and it was agreed that Wendron Parish Councillors support this application.

PA09/00644/F Mr J Neary – Conversion of redundant agricultural building to form four holiday lets and installation of a septic tank – Burnt House Farm, Porkellis. Cllr Hamilton proposed, Cllr Mrs Warren seconded and it was agreed that Wendron Parish Councillors have grave concerns about access to the proposed development which is along a narrow and tortuous Public Right of Way (which is not in the ownership of the applicant) where there are no passing places, where there would undoubtedly be a conflict of safety between vehicles and pedestrians/horse-riders and which emerges near Halwin School. They do not believe this access is safe for the level of expected use. Further, they do not believe the building itself is either worthy of retention or is capable of conversion without major or complete reconstruction. They therefore consider that the application is for new homes in the countryside and accordingly ask the Planning Committee to refuse permission for development.

Cllr Gibson declared a personal interest in the following application in that the applicant is an acquaintance. He remained in the room but took no part in the discussion or the voting.

PA09/00672/F Miss M Wilkinson – Erection of a replacement dwelling and domestic garage and installation of two septic tanks – East Calvadnack, Carnmenellis.
