The Chairman welcomed members and visitors to the Annual Meeting.

#### 1 ELECTION OF CHAIRMAN

Cllr Mrs Warren proposed, Cllr Hamilton seconded, Cllr Clayton and Cllr Gibson abstaining, all others in favour that Cllr Mrs Lay be elected to the Chair of Wendron Parish Council for the year 2010 – 2011.

## 2 CHAIRMAN'S DECLARATION OF ACCEPTANCE OF OFFICE

Cllr Mrs Lay read aloud, signed and dated the statutory Declaration of Acceptance of the Office of Chairman of Wendron Parish Council for the year 2010 – 2011 in the presence of the Council and Clerk.

## 3 ELECTION OF VICE-CHAIRMAN

Cllr Clayton proposed, Cllr Mrs Warren seconded and it was agreed that the election of a Councillor to the post of Vice-Chairman for the year 2010 - 2011 should be postponed until the June meeting.

# 4 APOLOGIES FOR ABSENCE

Apologies for absence were received from Cllr N.van den Berg and Cllr P.Davidson.

# 5 CONFIRMATION OF MINUTES OF PREVIOUS MEETING

Cllr Clayton proposed, Cllr Mrs Warren seconded, Cllr Mrs Mitchell being absent from the previous meeting abstained, all others in favour that, subject to the hand-written amendment, the minutes of the meeting held on Monday April 12, 2010 are a true record and the Chairman signed them as such.

## 6 MATTERS ARISING AND NOT COVERED ELSEWHERE IN THIS AGENDA

There were no matters arising which are not covered elsewhere in this agenda.

## 7 PUBLIC PARTICIPATION

Speaking before the meeting began of Planning Application PA10/00206/F Mr N Hosking – Temporary stationing of an agricultural worker's caravan – Land at Lower Burras Farm, Burras, Mr Pickett stated that this application has been withdrawn. However, there remains a need for an agricultural worker's caravan on this site and the application will be re-submitted. He further reported that the County Land Agent has indicated his initial support for a re-submitted application.

# 8 CORNWALL COUNCILLOR'S COMMENTS

CCllr Clayton stated that the national election has had the effect of postponing a number of difficult decisions which will have to be made by Cornwall Council. These decisions will affect front-line services. Moreover, because funding from central government will fall short, the money held by Parish Councils will be at risk unless Parish Councils have a good reason for holding it.

#### 9 POLICE REPORT

Through the Clerk, PC Vaughan reported that, in April, there had been three crimes reported to the Police: two of possession of cannabis (where both offenders have been cautioned) and a third of assault (where the offender was dealt with by way of Restorative Justice). This compares with five reported crimes in April of last year.

PC Vaughan further reported that Devon and Cornwall have been declared to be the fourth safest place to live in the United Kingdom. This year the county has experienced a 6.4% drop in crime.

#### 10 STANDING ORDERS

Cllr Clayton proposed, Cllr Boase seconded all in favour that Wendron Parish Council should re-adopt Standing Orders as fully revised in August 2007 and partly revised in August 2009.

## 11 FINANCIAL REGULATIONS

Cllr Hamilton proposed, Cllr Mrs Warren seconded all in favour that Wendron Parish Council should re-adopt Financial Regulations as last substantially revised in September 2007.

#### 12 RISK ASSESSMENT

Cllr Clayton proposed, Cllr Hamilton seconded all in favour that Wendron Parish Council should re-adopt the Risk Assessment document as last substantially revised in October 2007.

# 14 PROJECTS WITHIN THE PARISH

**Stithians Lake Highway Verge** – The Clerk reported that Rex Andrew had estimated that the cost of cutting the verge from the bridge over the river on Polighy Moor to the far end of Stithians Lake would be no more than £100. Cllr Clayton proposed, Cllr Hamilton seconded and it was agreed to ask Rex Andrew to undertake this work on the condition that Cornwall Highways are in agreement.

**Calvadnack Common** – It was agreed to seek a quotation for an hourly rate to clear a route up to and around the hut circles. It was also agreed that *Time Team* should be contacted with the suggestion that this might be a suitable subject for one of their television programmes.

**Public Seat in the Lawn Cemetery** – the Clerk reported that the seat in memory of Mr Searle is badly in need of repair and possibly of replacement. It was agreed that Mr Searle's family should be contacted to ascertain whether or not they would like to be involved in this matter.

Carnkie Play Area – the Clerk reported that funding applications for the Rotaweb at the play area in Carnkie had so far been unsuccessful. It was agreed that this project should be kept in mind.

**Car Park at Stithians Lake** – the Clerk reported that he had received no further information from the South West Lakes Trust about the application for planning permission for this much-needed car park.

**Housing Needs Survey** – Cllr Clayton asked if, in view of potential changes to planning policy regarding the construction of Local Needs dwellings, Wendron Parish Council would consider producing a Local Needs Housing document which would have planning relevance in the future. He intimated that such a

document could be produced with the help of officers of the Community Network. It was agreed to discuss this matter at a future meeting.

**Trinity Praze play area** – explaining that he had been approached by a group of children about the matter, Cllr Clayton asked if thought might be given to extending the play area at Trinity Praze. He agreed to give the Clerk details of the landowner whom the Clerk undertook to contact.

The Chairman proposed and it was agreed that because of the sensitive nature of this item members of the public should be required to withdraw from the meeting.

The Clerk reported that he had received an application for one of the four vacant places on Wendron Parish Council from Mr Clive Mitchell. Following discussion, Cllr Clayton proposed, Cllr Mrs Warren seconded all others in agreement that Mr Mitchell should be co-opted as a Parish Councillor.

Members of the public were invited to return to the meeting.

The Chairman announced the result of the vote.

Cllr Mitchell read aloud and signed his individual declaration of acceptance of office before Mr Chapman, Clerk to Wendron Parish Council, the Proper Officer. The Chairman welcomed Cllr Mitchell as a member of Wendron Parish Council.
