Minutes of the Ordinary Meeting of Wendron Parish Council held on Monday November 14, 2011 at 7:30pm in the Community Hall, Burras.

The Chairman welcomed members and visitors to the November meeting.

1 APOLOGIES FOR ABSENCE

Cllr Davidson, Cllr Maddern and PC Vaughan sent their apologies for absence.

2 CONFIRMATION OF THE MINUTES OF THE LAST MEETING

Cllr Mrs Warren proposed, Cllr Mrs Mitchell seconded, Cllr van den Berg and Cllr Mrs Lay being absent from the last meeting abstained, all others in favour that the minutes of the Ordinary Meeting held on Monday October 10 are a true record and the Chairman signed them as such.

3 MATTERS ARISING AND NOT COVERED ELSEWHERE IN THIS AGENDA

The Clerk reported that the notice-board for use at Rame is with our contractor and will be erected on site once the wall has been rendered by the owner of Rame Post Office. He showed members a plaque which will be fixed to this notice-board which draws attention to the fact that it has been part-funded by CCllr Mike Clayton.

It was noted that the Vehicle Advisory Sign is now, at last, up and working in Rame.

The Planning Enforcement team is aware of concerns about the Wheal Oak site on the B3297.

In answer to a question, the Clerk reported that, although he had been instructed at the last meeting to take whatever steps necessary to secure the fencing around the play area at Carnkie, it had become apparent that to do so would be quite expensive. He had therefore decided to obtain three quotations for the necessary work and to put them before the Parish Council before he issued instructions to go ahead. Having heard the quotations, the Chairman proposed and it was agreed that the Clerk should go ahead as instructed.

4 CORNWALL COUNCILLOR'S COMMENTS

In the absence of a Cornwall Councillor there was no report.

5 PUBLIC PARTICIPATION

Speaking on behalf of Mr and Mrs Berry (who were present to seek support for their planning application PA11/08611) Mrs Taylor said

- their application was the direct result of a change of policy at RNAS Culdrose. This now requires contractors to remove all their equipment once a job has been completed (in the past this has been left in storage on site in readiness for the next project)
- the applicants had taken advice from the planning officer before submitting their application.

It was noted that residents of Rame have serious concerns about proposed storage building and, in particular, its visual impact on the surrounding landscape.

Mr Care said he was present to address concerns expressed by Wendron Parish Council about his original planning application PA11/07055. He stated that

- he does own the land
- he has a ten year agreement with Natural England's Stewardship Scheme at the Higher Level: that is to say that in that time he has agreed to enhance the land for the benefit of wildlife
- 60% of the land is currently covered by European gorse and bracken all of which needs to be removed
- he has fenced the land to allow grazing by Hereford cattle
- the boggy areas represent a life-threatening danger to these animals
- the area where he intends to create the ponds are of no real benefit to wildlife, unlike the area further down the valley
- spoil from the ponds will be spread some four to six inches deep over the surrounding area
- the iron-age village half-way up the hill will eventually be exposed to view
- consultation with the Archaeological Department at Cornwall Council had revealed no concerns
- his intention is not to ruin the site but to enhance it.

Mrs Jenkin said that she was simply present to introduce herself and to state that she would be standing for election to Cornwall Council in the Wendron Ward.

6 POLICE REPORT

Through the Clerk, PC Vaughan reported that seven crimes (three thefts, a burglary, a sexual offence and two of criminal damage) had been reported to the Police in October 2011: a similar number had been reported in the same period last year.

The Police had been impressed with the responsible attitude shown by young people at Hallowe'en: just a single incidence of anti-social behaviour in the whole of the Helston sector had been reported.

PC Vaughan again reminded members and residents alike that the new non-emergency number is 101 adding that he, PCSO Berry and PCSO Bell may also be contacted on 01326 555158.

7 PARISH COUNCIL MATTERS

Councillor Mike Clayton

Members considered marking the contribution made to the Parish of Wendron during the course of the last twenty-five years by Councillor Mike Clayton. It was agreed that Mike would probably have preferred something practical and that perhaps two hard-wood benches, one sited in the play area at Carnkie and the other on the green outside would be suitable. Cllr Mrs Warren proposed, Cllr van den Berg seconded, all in favour that the Clerk should have delegated powers to purchase two suitable benches up to a combined value of £1,000

The co-option of Parish Councillors

The Clerk reported that no applications for co-option onto the Parish Council have been received.

8 PROJECTS WITHIN THE PARISH

Provision of a bus shelter at Trevenan Bal

The Clerk reported that he had spoken with Dave Vincent, Cornwall Council's Area Manager, about the possibility of constructing a bus shelter on the southern side of the A394 at Trevenan Bal. He (Dave Vincent) had agreed that the existing raised kerb built to ease access on and off buses is misplaced and recommended a site near the existing flag. The Clerk further reported that he had written to Andy James requesting the necessary permission to use the highway verge at this point for a bus shelter. He has since received this permission. He now awaits two quotations for constructing a shelter at this location both of which are required before an application for grant funding may be submitted. Cllr Mrs Warren agreed to consult Mrs Gronwallt who owns the nearby home about the matter before a decision to proceed is taken.

Local Needs Housing

Members noted the contents of the confidential written report on the informal meeting held with Mr Will Morris from Cornwall Council's Affordable Housing Department and Mr John Warner from Cornwall HomeChoice. Cllr Mrs Lay proposed, Cllr Mrs Moyle seconded, Cllr Gibson against, all others in favour that Mr Alan Fox and A.N.Other should be approached with a view to asking them to act as Wendron Parish Council's agent.

The Diamond Jubilee of HM Queen Elizabeth II

The Clerk reported that, as requested, he had sought prices for three Ghost Birch Betula utilis Jacquemontii 'Grayswood Ghost' trees, one each for both Halwin and Wendron Schools and one for the lay-by at Retanna to

The Clerk reported that, he is still awaiting a template for the site strapline for use by Frederick Wearne & Sons, otherwise the matter is in hand.

12 CHAIRMAN'S COMMENTS

The Chairman thanked Cllr Mrs Warren for chairing the meeting last month in her absence when she had been in Mexico.
