The Chairman welcomed members and visitors to the December meeting. In particular she welcomed CCllr Dr Jenkin and congratulated her on her success in the recent by-election.

1 APOLOGIES FOR ABSENCE

Cllr Maddern sent his apologies for absence.

2 CONFIRMATION OF THE MINUTES OF THE LAST MEETING

Cllr Mrs Moyle proposed, Cllr van den Berg seconded, Cllr Davidson being absent from the last meeting abstained, all others in favour that the minutes of the Ordinary Meeting held on Monday November 14, 2011 are a true record and the Chairman signed them as such.

3 MATTERS ARISING AND NOT COVERED ELSEWHERE IN THIS AGENDA

There were no matters arising which were not covered on the agenda.

4 CORNWALL COUNCILLOR'S COMMENTS

Thanking those who supported her in the recent by-election and stating that she was looking forward to working with the Council, CCllr Dr Jenkin reported that

- she now has a Cornwall Council e-mail address letjenkin@cornwall.gov.uk
- at a recent meeting Cornwall had voted to be minded to accept a grant from Central Government equivalent to a 2.5% increase in Council tax in return for freezing Council tax at current levels
- at the same meeting, Cornwall had agreed to tell the Government that, if the May Day bank holiday is moved, the Council would wish to see it replaced in Cornwall by a public holiday on St Piran's Day
- many environmental organisations (including the National Trust and CPRE) are concerned about changes in planning as proposed by the Government, principally because landscapes and countryside that are not presently covered by specific environmental designations will have no protection and there will be a presumption in favour of development in those areas. It appears that the only way that control will be able to be exercised is through the higher level Core Strategy or through very locally applied neighbourhood plans and orders. These will have to be adopted through a costly planning process and local referendum
- she is particularly concerned with the need to develop a strategic approach to small scale wind generation across the division and is arranging a meeting with planning officers to discuss this.

5 PUBLIC PARTICIPATION

Mr Johns asked the Council if it would reconsider the observations it made on his application for the erection of a wind turbine at Carnkie. The turbine he has chosen is reliable and quiet and will therefore not impose on neighbours. It will additionally provide a steady source of income for his family.

Mr Hobson said he was present to support Mr Johns' request. Nationally and internationally there is a growing demand for the production of non-pollutant 'green' energy which is reflected in Planning Policy Statements. The proposed turbine will rest on a lattice framework and will blend in with existing pylons: it will not be an eye-sore.

Mr Sankey said that he was present simply to hear what the Parish Council had to say about the proposed erection of three wind turbines at Nancrossa Farm in Rame

The Diamond Jubilee of HM Queen Elizabeth II

The Clerk reported that he had taken delivery of three eight foot high Ghost Birch *Betula utilis Jacquemontii* '*Grayswood Ghost*' trees, one each for both Halwin and Wendron Schools and one for the lay-by at Retanna to mark the occasion of HM Queen Elizabeth II's Diamond Jubilee. Together with tree stakes, ties and delivery the net cost had been £137.46

9 FINANCE

The Clerk presented Councillors with a statement of Wendron Parish Council's financial position as at December 2, 2011. A copy of that statement is attached to these minutes.

Following discussion, it was proposed by Cllr Mrs Warren, seconded by Cllr van den Berg all in favour that the Precept for the year 2012/2013 should be set at £24,750. Councillors noted that this will be the third year in succession that the Parish has made no increase in its demand on Council Tax payers.

The Clerk outlined problems he had recently experienced with the Parish Council's Bankers, Santander. Following discussion,

- Cllr Mrs Lay proposed, Cllr Mrs Moyle seconded all in favour to close the two accounts held with Santander as soon as is practical.
- Cllr Mrs Lay proposed, Cllr Mrs Warren seconded all in favour to appoint Barclays Bank plc as Wendron Parish Council's bankers as soon as is practical
- Cllr Mrs Lay proposed, Cllr Mrs Mitchell seconded all in favour that both a deposit account and a current account should be set up to allow the Council to carry out its business.
- Cllr Mrs Lay proposed, Cllr van den Berg seconded all in favour that there should be three authorised signatories to the current account run by Barclays Bank plc and that a minimum of two of those signatories should sign all cheques and mandates.
- Cllr Mrs Lay proposed, Cllr Davidson seconded all in favour that a single authorised signatory may give instructions to move money both from the deposit account to the current account and from the current account to the deposit account.
- Cllr Mrs Lay proposed, Cllr Mrs Moyle seconded all in favour that for the time being the three authorised signatories should be Cllr Mrs Lay, Cllr Mrs Warren and the Clerk, Mr Chapman.

Members considered a request from Victim Support for financial help with funding its work. Following discussion, it was proposed by Cllr Davidson, seconded by Cllr Mrs Lay, all others in favour that the sum of £75.00 be forwarded to Victim Support under the terms of Section 142(2A) of the Local Government Act 1972.

10 PLANNING

Applications

As a neighbour of the applicant, Cllr Davidson declared a personal interest in the following application. As a friend of the applicant, Cllr Mrs Moyle declared a personal interest in the following application. They both remained in the room but took no part in either the discussion or the voting.

PA11/07442 Mr S.Toft – Replacement of the approved Proven P35 wind turbine with a smaller, quieter 15m P11 wind turbine in a revised location – Little White Alice, Calvadnack. Cllr Mrs Lay proposed, Cllr Mrs Warren seconded, all others in favour that this application should be returned with the following observation "Wendron Parish Council supports this application, subject to a favourable report from the Environmental Health Officer."

PA11/09157 Rev A Hill – Listed Building Consent for the removal of organ from closed chapel (amended plans) – Carnkie Methodist Church, Carnkie.. Cllr Mrs Lay proposed, Cllr Mrs Warren seconded, all in favour that this application should be returned with the following observation "Wendron Parish Council supports this application and, as long as the instrument is removed without damage to the structure, fabric or finishes of the Chapel, would request that, should approval be granted, exceptionally, the Planning Authority dispenses with any requirement for a full planning application."

PA11/09161 Mr Jim Ravey – Installation of 3 No x 50kW wind turbines (24.6m to hub, 34.2m to tip), access track and associated ancillary development – Lower Nancrossa Farm, Halfway House, Rame Cross. Cllr Mrs Lay proposed, Cllr Mrs Warren seconded, all in favour that this application should be returned with the following observation "Wendron Parish Council understands that a number of residents living in close proximity to the site have not been informed of this application and urges the Planning Authority to make every effort to contact them.

In respect of the Planning and Design Statement submitted with this application, Wendron Parish Council notes with bemusement the reference to South Somerset Council on page 30 and the reference to the A303 on page 34.

"However...

"There has been no pre-application consultation with the community, contrary to EHS Guidelines 2007.

"It is noted that a request for an EIA Screening Opinion was submitted to Cornwall Council (page 8 Planning and Design Statement) but that no response has been received. Wendron Parish Council urges the Planning Authority to reply positively to this request.

"Wendron Parish Council believes the scale of the turbines will be grossly out of proportion with the surrounding landscape and will have an adverse affect on the residents of the many small communities surrounding the site.

"It is noted that there are existing dwellings well within 500 metres of the proposed turbines. Wendron Parish Council considers the proposed turbines will impose on residents' quiet enjoyment of those properties.

"The applicant has used the recommendations outlined in ETSU-R-97 (Noise Assessment and Rating advice note for Wind Turbine Developments) to suggest that the noise generated by the proposed turbines would be unnoticed by residents of neighbouring properties. This document was written fourteen years ago and both wind farm technology and experience in environmental effects have advanced since its publication and the recommendations contained within the document are therefore open to question. Wendron Parish Council cannot accept the generalised assurances of a company employed by the applicant nor indeed those of the manufacturer that the proposed turbines will be "very quiet". The average windspeed at a height of 10 metres above ground level at this location is 7.3 m/s (source DECC). According to the document submitted by the applicant, this wind-speed equates to just over 89 decibels (that of a motor-cycle at 20 feet or a propellor-driven plane at 1,000 feet). It is Wendron Parish Council's view that this continuous level of noise is unacceptable.

"It is noted that the position of all three turbines is at odds with Natural England's guidelines as outlined in its Technical Information Note TIN051.

"It is noted both that a section of Bridleway 99 represents the access route for construction and inspection vehicles and that the remaining section of this Bridleway passes within 50 metres of the site of the proposed turbines. No method of ensuring the safety of members of the public making use of this Right of Way either during construction or upon completion is detailed in the Design and Access Statement contrary to RenewableUK Guidelines.

"The size, siting and prominence of the turbines would appear as a dominant and visually intrusive feature in the surrounding rural landscape and would be imposing and overbearing on views of and from this ridge, which, at 630 feet, dominates the sky line for miles around.

"The plans indicate that the turbines will be visible from the far side of Truro, from Cadgwith, from Penzance, from

St Ives and from St Agnes – an area in excess of 1,256 square kilometres or more than a third of the entire area of Cornwall. It is an area which attracts tourists from all over the world who come principally to enjoy the rural charm of the landscape. In 2009 Cornwall attracted 15.1 million visitors who spent approximately £1.8 billion pounds (which supported approximately 60,000 jobs across the county or 25% of the total employment): there is every reason to believe that these figures have increased more recently. The erection of turbines on this site may have an adverse effect on the local economy and, for this reason, Wendron Parish Council believes that a Tourism Impact Study of the area should have been carried out.

"For all the above reasons, Wendron Parish Council requests the Planning Authority to refuse permission for development. The visual impact and intrusion into the countryside of the proposed turbines is contrary to policies 1 and 2, of the Cornwall Structure Plan 2004 and ENV1, ENV4 and ENV17 of the Draft Kerrier District Local Plan 2004. Wendron Parish Council also believes the cumulative impact of turbines of differing sizes within the area (PPS22 paragraph 21 and Policy 7 of the Cornwall Structure Plan 2004) militates against permission for further turbines being granted.

"Finally, Wendron Parish Council would draw the attention of the Planning Authority to the decision to refuse permission for development for the erection of a single turbine and ancillary building at Polkanuggo Farm (PA11/01263)."
