The Chairman welcomed members and visitors to the Annual Meeting.

1 ELECTION OF CHAIRMAN

Cllr Mrs Mitchell proposed, Cllr Miss Nute seconded, all others in favour that Cllr Mrs Warren be elected to the Chair of Wendron Parish Council for the year 2013 - 2014.

2 CHAIRMAN'S DECLARATION OF ACCEPTANCE OF OFFICE

Cllr Mrs Warren read aloud, signed and dated the statutory Declaration of Acceptance of the Office of Chairman of Wendron Parish Council for the year 2013 – 2014 in the presence of the Council and Clerk.

3 ELECTION OF VICE-CHAIRMAN

Cllr Mrs Warren proposed, Cllr Mitchell seconded, all others in favour that Cllr Mrs Moyle be elected to the post of Vice-Chairman for the year 2013 - 2014.

4 APOLOGIES FOR ABSENCE

Apologies for absence were received from Cllr Davidson and PCSO Wickford.

5 CONFIRMATION OF MINUTES OF PREVIOUS MEETING

Cllr Mrs Mitchell proposed, Cllr Mrs Moyle seconded, Cllr Mrs Hook and Cllr Miss Nute abstained, all others in favour that the minutes of the meeting held on Monday April 8, 2013 are a true record and the Chairman signed them as such.

6 MATTERS ARISING AND NOT COVERED ELSEWHERE IN THIS AGENDA

There were no matters arising which are not covered elsewhere in this agenda.

7 PUBLIC PARTICIPATION

Further to the concerns expressed at the last meeting about both the existing solar farm at Edgcumbe and about potential similar development in the same area, Mr Binnie reported that he had contacted Mr George Eustice, the local Member of Parliament, who had agreed to speak to residents and who, Mr Binnie understands, will approach Cornwall Council about these developments with a request for a moratorium on this sort of development within the immediate area.

Further concerns were expressed about the proposal for the development of local needs affordable homes in Rame. The Clerk assured those present that Cornwall Rural Housing (the developer) will involve local people in the process by means of a public meeting later in the year.

8 CORNWALL COUNCILLOR'S COMMENTS

CCllr Dr Jenkin reported that, having spent the last month knocking on doors and listening to residents' issues, she had nothing to report from Cornwall. She thanked those who had voted for her and said that she looked

forward to being involved in four years of parish projects, adding that she will be making every effort to resolve the issues relating to the A394 at Trewennack. She suggested that the Parish might consider writing a Neighbourhood Plan with the aim of informing the planning process at local level.

Speaking on behalf of Wendron Parish Council, the Chairman congratulated CCllr Dr Jenkin on her election and stated that the Council looks forward to working with her during the course of the coming four years.

9 POLICE REPORT

Through the Clerk, PCSO Whitford reported that eight crimes (including three of theft, three of criminal damage and one in which a motor-cyclist was hit by a stone) were reported to the police in April. PCSO Whitford warned residents to take particular care with the security of fuel held both in vehicles and for domestic heating. Incidents involving fly-tipping should be reported either to Cornwall Council or to the Police using the non-emergency number 101.

10 STANDING ORDERS

With the proviso that Standing Orders should be fully revised during the course of the coming year, Cllr Mrs Warren proposed, Cllr Mrs Moyle seconded, Cllr Mrs Hook and Cllr Miss Nute abstained all others in favour that Wendron Parish Council should re-adopt Standing Orders as fully revised in August 2007 and further revised in August 2009, September 2010 and May 2011.

11 FINANCIAL REGULATIONS

Cllr Mrs Warren proposed, Cllr Mrs Mitchell seconded, Cllr Mrs Hook and Cllr Miss Nute abstained all others in favour that Wendron Parish Council should re-adopt Financial Regulations as last substantially revised in September 2010.

14 PROJECTS WITHIN THE PARISH

Trelill Holy Well

Members considered the award of a donation towards the cost of the work currently being undertaken on Trelill Holy Well in Trewennack. Following discussion, Cllr Miss Nute proposed, Cllr Mrs Mitchell all in favour that the Clerk should contact Mrs Ann Preston-Jones of the Cornwall Historic Environment department with a view to identifying a project associated with the renovation of Trelill Holy Well which Wendron Parish Council sponsor up to the sum of £500.

Edgcumbe bus shelter

The Clerk reported that the construction of a replacement bus shelter on the A394 at Edgcumbe is complete.

Purchase of a defibrillator

Members considered the purchase and position of a defibrillator. Following discussion, it was agreed to defer making any decision about this matter to the next meeting.

The gate into Wendron cemetery

The Clerk reported that the repair or replacement of the gate into Wendron cemetery is perhaps overdue. Following discussion, members agreed that the Clerk should seek quotations from suitably qualified wrought iron manufacturers.

15 PARISH COUNCIL MATTERS

Appointment of the Internal Auditor for the year to March 31, 2013

Cllr Mrs Warren proposed, Cllr Mrs Mitchell seconded and it was agreed that Mr J.P.Richards (formerly Kerrier District Council's Senior Auditor) should continue to act as Wendron Parish Council's internal auditor.

Co-option of Parish Councillors

Members noted that the full Council lacks seven members. It was agreed to place advertisements on the notice-boards inviting expressions of interest in co-option onto the Council.

Local Maintenance Partnership

Members considered an invitation to renew partnership working with Cornwall Council with the offer of a grant of £4,979.00 (or 100% of the eligible costs whichever is the lower). In the year to March 31, 2013 Wendron Parish Council's costs for cutting Public Rights of Way amounted to £5,179.61 and a grant of £4,990.02 from Cornwall Council was claimed. Cllr Miss Nute proposed, Cllr Mrs Moyle seconded, all others in favour that Wendron Parish Council should accept Cornwall Council's invitation to renew partnership working.

Renewal of Insurance Policy
