## 5 CORNWALL COUNCILLOR'S COMMENTS

CCllr Dr Jenkin reported that, since the last meeting

- she has been actively involved both with a number of planning applications
- and with flooding issues in Trenear. She asked members to report details of floods within the Parish both to her and to Cornwall Council (so that she may co-ordinate remedial work within her Ward)
- together with the Chairman, she had been present at an informal ceremony at Halwin Pre-School to mark the completion of the new heating system. (Here the Chairman reported that she had been given a card made by the children thanking the Parish Council for its contribution towards the cost of this project)
- the formal appointment of a new head teacher at Halwin School is proceeding with entries closing today and a short list being prepared for the end of next week.

#### 8 PARISH MATTERS

# To consider the repair of the lane leading up to Carnkie Wendron Village Hall

The Clerk reported that a pipe which forms part of the drainage system off the hill and which runs under a driveway has become blocked and that the resultant overflow has damaged the surface of the lane, again. In discussion with Mr Rex Andrew it appears that the best (and most permanent) way forward will be to tarmac the lane having first unblocked the pipe. Mr Andrew has estimated the cost of tarmac-ing the lane in the sum of £1,825. Following discussion, Cllr Mrs Warren proposed, Cllr Mrs Nute seconded, two members against and one abstaining, to instruct Mr Rex Andrew to carry out the necessary repair and to seek contributions towards the cost of this work from householders living on the lane.

# The purchase of a defibrillator

Mr Peter Thorne from Wendron Cricket Club introduced Mrs Heather Jalbert of the Cornwall Football Association who spoke about a scheme which is run by the British Heart Foundation for purchasing a defibrillator. She stated that the cost is underwritten by the Foundation and that as a result a new instrument costs the purchaser about £400 with training and renewables on top. If the Parish Council is prepared to donate the money, the Club will arrange for the purchase of a defibrillator, training, insurance and maintenance. Following extensive discussion, Cllr Mrs Warren proposed, Cllr van den Berg seconded, three members abstaining, all others in favour that Wendron Parish Council should pay Wendron Cricket Club a sufficient sum of money to enable this project to go ahead.

## The purchase of a notice-board for Edgcumbe

The Clerk reported that Bear Joinery is now in the process of constructing this board.

#### The replacement of the gates into Wendron cemetery

Presenting Members with a picture of the gates before they are sent for galvanising and powder coating, the Clerk reported that Mr Tristan Kessell has asked for a further payment of £700 to cover this cost and that, all being well, the gates themselves will be hung before the meeting in February. Following discussion, Cllr Mrs Nute proposed, Cllr Mrs Moyle seconded, one member against, all others in favour to pay Mr Tristan Kessell a further instalment of £700.

# **Trelill Holy Well**

The Clerk reported that Mrs Ann Preston Jones of Cornwall Council's Historic Environment Service had written to say that the restoration project is very nearly complete. The donation made by Wendron Parish Council will pay for four cast metal direction signs.

## **Local Need Affordable Housing**

The Clerk circulated members with copies of Cornwall Community Land Trust's Draft Allocations Policy and Draft Local Lettings plan which had been forwarded for comment. Members noted that the Trust has arranged a public consultation event concerned with the provision of local needs affordable housing on the site at Rame to be held at Edgcumbe Methodist Church on Wednesday January 22 between 2.00pm and 6.00pm
