There were no matters arising which were not covered elsewhere in this agenda.

5 CORNWALL COUNCILLOR'S COMMENTS

CCllr Dr Jenkin reported that, since the meeting in June, she has attended a number of meetings dealing with everyday matters of planning (including site meetings) and enforcement. She was present at the drop-in event on plans for north-east Helston (HX1). She has also discussed a number of issues of concern to the parish with Highways Officers including

- the continuing absence of a report on the inconsiderate and illegal use of speed at Edgcumbe and Rame
- temporary siting of measured constant speed cameras in Trewennack
- the creation of pedestrian and cycle routes into Helston from Trewennack

CCllr Dr Jenkin further reported that an indicative scheme for the A394 as an economic driver for Helston should be ready by the end of August. This may address many of the concerns besetting residents of Trewennack.

In answer to questions from Cllr Gibson about enforcement issues at Polgear Cottage, CCllr Dr Jenkin stated that action should have been taken in 2008 and that in the absence of that action the matters are now out of time. The Chairman told Cllr Gibson that this issue must now be dropped: Cllr Gibson indicated that he would take the matter forward personally.
