1 APOLOGIES FOR ABSENCE

3 CONFIRMATION OF THE MINUTES OF THE LAST MEETING

Cllr Mrs Moyle proposed, Cllr Mrs Mitchell seconded, (Cllr Mrs Hook, Cllr Mrs Nute and Cllr Tremayne, who were absent from the last Meeting, abstained) all others in favour that, with the addition of the hand-written amendments, the minutes of the Ordinary Meeting held on Monday July 14, 2014 are a true record and the Chairman signed them as such.

4 MATTERS ARISING AND NOT COVERED ELSEWHERE IN THIS AGENDA

There were no matters arising which were not covered elsewhere in this agenda.

5 CORNWALL COUNCILLOR'S COMMENTS

CCllr Dr Jenkin reported that, since the meeting in July

- Cornwall Council has been considering next year's budget and more particularly a predicted shortfall of £196m (which will inevitably result both in further job losses and in the loss of front-line services)
- a single mobile library van, which is intended to cover the whole of Cornwall, is being retained by Cornwall Council. Clearly, it will only have a limited number of stops (but quite where has not, as yet, been decided). Communities will be encouraged to create their own micro-libraries
- the demand for Health and Social Care in Cornwall has and will increase, but the overall budget will remain the same. This implies that individuals will be expected to pay more towards their care
- Cornwall Councillors have been asked to submit requests for road improvements in their wards by the end of next week. CCllr Dr Jenkin will be submitting concerns about as many issues as she can: these include the provision of 'gateways' into all villages, a revision of speed limits along both the A394 and the B3297 and the creation of yellow-lined no-parking areas. She asked Members to let her know of further highways' concerns
- she has again asked the Officers concerned for reports on accidents on the A394 to be forwarded to her. Two

further incidents were recorded: one at Edgcumbe and the other at Laity

- the initial proposal for an average speed camera to be positioned in Trewennack is out for consultation
- she has requested the attendance of a Senior Highways Officer at a future meeting of the Council
- she has dealt with a number of planning and planning enforcement issues.

6 POLICE REPORT

Through the Clerk, PCSO Whitford reported that three crimes (of burglary, of threats and of harassment) were reported to the police during the month of July.

7 PUBLIC PARTICIPATION

There were no comments from members of the public.

8 PARISH MATTERS

Creation of a Neighbourhood Plan

Following the earlier presentation by Mrs Maxine Hardy, (Community Network Manager Helston and the Lizard), and Chloe Pitt (Cornwall Council Planning Officer) of an overview of Neighbourhood Plans and the manner in which development of such a plan might be of assistance to Wendron Parish Council, it was agreed that, in view of the wealth of information, the matter be deferred to a future meeting.

The purchase of a defibrillator

The Clerk reported that he had heard nothing further from Wendron Cricket Club about this matter.

The purchase of a notice-board for Edgcumbe

The Clerk reported that he had no further news to report about this matter.

To consider the erection of a panel fence between the play area and Mr Cruikshanks' land

The Clerk reported that he had received a complaint from Mr Robert Cruikshanks concerning problems relating to the interaction between the users of the play area and his dog. The best way forward would appear to be the erection of a panel fence along the eastern edge of the play area: he suggested that the materials for such a fence would cost in the region of £500. Mr Cruikshanks had agreed to erect the fence if the Parish Council would buy the panels and posts. Following discussion, Cllr Mrs Moyle proposed, Cllr Mrs Hook seconded, one member against all others in favour that the Clerk should purchase the necessary panels and posts and that they should be delivered to Mr Cruikshanks at Chapel Farm.

9 PARISH COUNCIL MATTERS

Co-option of Councillors

The Clerk reported that he had received an expression of interest in standing for co-option as a Parish Councillor from Mrs Hampton.

Following discussion, Cllr Mrs Nute proposed, Cllr Mrs Hook seconded, all others in agreement that Mrs Hampton should be co-opted as a Parish Councillor.

Cllr Mrs Hampton read aloud and signed her declaration of acceptance of office before Mr Chapman, Clerk to Wendron Parish Council, the Proper Officer. The Chairman welcomed Cllr Mrs Hampton as a member of Wendron Parish Council.

Wendron Lawn Cemetery

Members considered the charges relating to Wendron Lawn Cemetery. Following discussion, Cllr Davidson proposed Cllr Mrs Moyle seconded, Cllr Mrs Hampton abstained all others in favour to adopt the following changes

Members noted that

- the triangle in the middle of the road junction at Penmarth needs a more regular tidy: the Clerk will ask Gareth Mitchell to attend to this.
