## 5 CORNWALL COUNCILLOR'S COMMENTS

CCllr Dr Jenkin reported that

- she had attended the planning appeal concerned with the construction of two houses on land at Lowertown. It was her belief that the Planning Officer's defence of the Authority's decision to refuse permission had not been as robust as it might have been: in particular, the ecological report presented by the applicant had been shallow and the Helston Town Framework document referred to had been a draft rather than the final version
- the HX1 application which the Parish Council will consider this evening is a new application which, although it mirrors the original application in every detail, must be treated as a new application. She had attended the recent public meeting at Helston School at which the proposals had been on show, but reported that it was apparent that no-one present had been in favour: rather they had expressed concerns about the development's impact on Rowes Lane and on that corner of Helston

- the planning application for the conversion of the goat shed at Little Menherion will, somewhat surprisingly, be decided by the Planning Committee. Wendron Parish Council had supported the application, as had many local people. CCllr Dr Jenkin was asked to represent the views of Wendron Parish Council at the meeting
- the recent meeting with Highways' officers at Edgcumbe had proved useful in letting the department know the strength of feeling within the Parish, but the lack of money means that there is little that can be done in the immediate future. It is imperative that the aspirations of the Parish are incorporated in the new Local Transport Plan
- the best news is that, as part of a pilot scheme and before the end of the present financial year, average speed cameras will be fitted in Trewennack. Clearly, this initiative will make a huge difference to residents of the village.

# 11 PLANNING

# **Applications**

PA14/11142 Jackamax Ltd – Outline application for up to 340 residential dwellings (including affordable homes), building for use for B1 offices and medical practice, means of access and all other matters reserved – HX1 Helston Urban Extension Land West Of Trewennack. Cllr Mrs Moyle proposed, Cllr Mitchell seconded, Cllr van den Berg against, all others in favour that this application should be returned with the following observation Wendron Parish Council feels that this proposal is for a disconnected, dormitory suburb located on the margin of Helston. The distance to the centre of town well exceeds the 800m advised in the Manual for Streets as the distance which residents may access comfortably on foot and the majority of residents of the proposed development will undoubtedly use privately-owned motorised transport to go about their day-to-day business, contrary to the constraints of the National Planning Policy Framework.

No consideration has been given to the existing infrastructure of the immediate area. The road system struggles to cope with the number of vehicles already using it and there are further concerns associated with the supply of electricity, mains water and sewerage systems in this area of Helston. Furthermore, (and despite the applicant's

proposals to alleviate the risk) residents of the neighbouring estate, who are aware of and who have suffered from flooding, express concerns about the very real threat of rain-water run-off from the hard surfaces of this proposed development.

Wendron Parish Council has been involved in the work which has led to the development of the Helston Town Framework which is designed to inform and guide development of the Town over the next twenty years. Following extensive local consultation this document favours the development of a site other than this.

Wendron Parish Council cannot support this proposal and therefore requests the Planning Authority to refuse permission for development.

PA14/11333 Mr Mark Wrowe – Loft conversion and rear extension and associated works. Inclusion of a balcony at first floor level on the rear elevation – Innisidgen, Porkellis. Cllr Mrs Moyle proposed, Cllr Mrs Nute seconded, all others in favour that this application should be returned with the following observation *Although Wendron Parish Council has serious concerns about the potential for loss of privacy and light from neighbouring properties, it is prepared to support the application subject to the approval of the neighbours.*
