5 CORNWALL COUNCILLOR'S COMMENTS

CCllr Dr Jenkin reported that

- the application for holiday eco-lodges at Little Menherion was refused permission for development at a recent meeting of the West Planning Committee. She had been disappointed with the officer's report and recommendation
- the Strategic Planning Committee had unanimously rejected the application for an urban extension on HX1
- she noted that neighbours had objected to the proposed loft conversion, rear extension and associated works at Innisidgen in Porkellis. (The Clerk stated that a letter supporting these objections and therefore seeking refusal for development had been forwarded to the Planning Authority)
- the Local Plan has been adopted for examination in public and, if approved, looks likely to go through in June or July
- Halwin School is working on its philosophy preparatory to producing statements of aims and beliefs

Cllr Mrs Warren proposed, Cllr Mrs Nute seconded, one member abstaining, all others in favour that this application should be returned with the following observation Wendron Parish Council sees no reason to alter the observation it made on the original application (PA10/07595) viz Wendron Parish Council believes the proposed extension constitutes an over-development of the site and therefore seeks refusal of planning permission for development.

PA14/11761 Mr and Mrs D.Davy – Proposed re-design of approved scheme PA12/01953 (conversion of farm building to dwelling) – Barns adj to Trelill House, Falmouth Road, Helston. Cllr Mrs Warren proposed, Cllr van den Berg seconded, all others in favour that this application should be returned with the following observation *Wendron Parish Council supports this application*.

Cllr Mrs Nute declared a disclosable pecuniary interest in the following application. Using the authority delegated to him by Wendron Parish Council under Section 33 of the Localism Act 2011 the Clerk granted a dispensation to Cllr Mrs Nute allowing her to remain in the room, to take part in the discussion but to refrain from voting.

PA14/11848 Mrs J.Herron – Outline planning permission for two affordable and two open market dwellings – land west of Hillinton, Carnkie. Cllr Mrs Hook proposed, Cllr Mrs Mitchell seconded, Cllr Mrs Nute abstained, all others in favour that this application should be returned with the following observation Wendron Parish Council notes that the application is essentially for the development of an exception site within the settlement of Carnkie. However, it does not believe that the application properly identifies the need for affordable houses of the proposed size in this location nor does it believe that, once constructed, they will be affordable in terms of local income. The Council therefore views the application as being for the development of four new homes in a location that is unsustainable in terms of the National Planning Policy Framework and accordingly requests the Planning Authority to refuse permission for development.

13 CHAIRMAN'S AND COUNCILLORS' COMMENTS

The Chairman stated that it is her opinion that if the Council is to protect its environment, its buildings and its special sites then it is essential for it to have a Neighbourhood Plan in place. She warned members that it will take a great deal of work, that all parishioners will have to be involved, that considerable volunteer help will be essential and that the final document will have to jump through a number of hoops before it is adopted. She suggested that the work necessary might be done using an advisory committee of the Parish Council and, with that in mind, she invited those members interested in the project to contact her within the next week or so with a view to arranging an initial meeting.

Cllr Mitchell stated that, in repairing the road down from Rame Post Office to the Stithians junction, Cornwall Highways have obliterated the yellow 'No Parking' lines. He had reported the matter.

Cllr Gibson asked if Gareth Mitchell might be asked to help him clear the 'bubble-up' in Penmarth, warning that a cold snap would result in a sheet of ice covering the road: this was agreed.
