5 CORNWALL COUNCILLOR'S COMMENTS

CCllr Dr Jenkin reported that

- due to circumstances, she has attended fewer meetings than is normally the case
- the Strategic Planning Committee has refused the second application for the development of HX1. The appeal from the applicants as a result of the Authority's non-determination of the first application will be heard on July 7, 8 and 9: the Parish Council's opinion would be valued
- she has attended a site meeting at Roses Farm concerning the proposed turbine
- it is her view that the *Case for Cornwall*, which is being presented to Central Government and which is based on a similar document written by Wiltshire Council, should be seeking the devolution of more powers

6 POLICE REPORT

No report from the Police had been received.

7 PUBLIC PARTICIPATION

With reference to PA15/03798 (the siting of a single wind turbine with a tower height of up to 21.1m and a tip height of up to 34.2m along with associated infrastructure at Roses Farm, Black Rock), members noted that

- Roses Farm is a family dairy farm which was purchased in the 1950s
- five generations of the same family have worked the farm
- lowering the electricity bill would help to keep the farm competitive
- other green energy options have been considered
- the application is for a small turbine and the electricity generated will be fed directly into the farm
- the turbine is one of the quietest on the market
- the applicants are willing to arrange a site visit
- the nearest neighbour lives in a Grade II listed dwelling
- it appears that the applicant has not read the application
- the Bat Study lacks rigour and robustness: it picks and chooses which of the required guidelines to follow
- nearby trees and building are thirty feet high: the area enjoys long uninterrupted views
- the proposed turbine which is thirty metres in height will intrude on the visual aspect of the area
- it will generate extra noise
- it will devalue existing nearby dwellings
- it may lead to further similar applications
- it is not in the wider interests of the community and
- the Prime Minister has stated that turbines need the support of the community.

Mr Witheywood stated that he and his wife were present to seek the Parish Council's support for PA15/04247 adding that permission has already been granted for a dwelling of similar size and that this application primarily seeks permission to alter its position on the site. He stated that there would be no overlooking and that he and his wife are trying to be as environmentally friendly as possible.

Mr Thomas stated that he was present to seek the Parish Council's support for PA15/03912

PA15/03721 Mr and Mrs C.Brookes – Conversion of barn to dwelling – South Boderwennack, Trevenen Bal. Cllr Mrs Warren proposed, Cllr Mrs Mitchell seconded, all others in favour that this application should be returned with the following observation *Wendron Parish Council supports this application*.

PA15/03798 Mr & Mrs P & J Jenkin – Siting of a single wind turbine with a tower height of up to 21.1m and a tip height of up to 34.2m along with associated infrastructure – Roses Farm, Black Rock. Cllr Mrs Nute proposed, Cllr Mrs Hook seconded, Cllr van den Berg and Cllr Mrs Warren abstaining, all others in favour that this application should be returned with the following observation Wendron Parish Council notes that the proposal site lies within an Area of Great Landscape Value and within 500 metres of (and may therefore be considered detrimental to) a Listed Building. It notes that the proposed site of the turbine is contrary to Natural England's Technical Information Note TIN 051 (the hedge is well within the recommended 50m of the sweep of the rotor). and therefore believes the turbine will have a detrimental effect on the wildlife of the area

The Council believes that the noise the turbine will generate in operation will have an adverse effect on the quiet enjoyment of all properties in the immediate area. It further believes it will have a significant negative visual impact on the character of the rural landscape. More generally, if the turbine is built, there is the potential for an adverse impact on tourism and consequently on the micro businesses in the area.

For all the above reasons, Wendon Parish Council requests the Planning Authority to refuse permission for development.
