# 5 CORNWALL COUNCILLOR'S COMMENTS

Wishing everyone a happy new year, CCllr Dr Jenkin reported that

- considerable paperwork aimed at strengthening planning rules relating to future development within the Cornish Mining World Heritage Site and the Cornwall Area of Outstanding Natural Beauty, together with the newly written Environmental Strategy is all being put together to accompany the revised Local Plan when it is returned to Central Government for approval. (At present, in Cornwall, there is a lack both of protection and of enforcement within these two nationally designated areas: for example, structures which are contextually important within the landscape are not infrequently removed without consultation)
- the Lowertown Community Group is keen to become involved in the Neighbourhood Plan and has invited a Councillor to attend its next meeting
- she has some money left in her share of this financial year's Community Chest: groups who wish to apply to her for financial help should send in their applications before the end of the month

• an all-party delegation has met with officers of the Boundary Commission to express alarm at the time-scale of the proposed Boundary Review. The delegation does not believe there is sufficient time between now and the elections in May 2017 to make properly informed decisions and, accordingly, has asked for the Review to be postponed. The outcome is awaited.

CCllr Dr Jenkin asked to be kept informed of all flooding and drainage issues within the parish.

#### 6 POLICE REPORT

## **Applications**

PA15/10893 Mr and Mrs Borman – New build agricultural barn – Waterside, Carnmenellis. Cllr Tremayne proposed, Cllr Mather seconded, all others in favour that this application should be returned with the following observation *Wendron Parish Council supports this application*.

PA15/11471 Mr and Mrs I.Carpenter – Erection of a two-storey extension – Trelubbas Wartha House, Redruth Road, Wendron. Cllr Mrs Neary proposed, Cllr Mrs Warren seconded, all others in favour that this application should be returned with the following observation *Wendron Parish Council supports this application*.

During the course of discussion of the following item, the Chairman proposed and it was agreed to suspend Standing Orders to allow Mr and Mrs Wilkinson the opportunity to answer members' questions.

PA15/11664 Mrs Shauna Wilkinson – To install a 25m x 40m all-weather surface riding ménage within the easternmost field of land (south-western corner to west of stables) – Old Carpenters Workshop, Polmarth. Cllr Mrs Warren proposed, Cllr Mrs Neary seconded, three members abstained, all others in favour that this application should be returned with the following observation *Wendron Parish Council does not believe the application contains sufficient information for it to be able to make an informed observation*.

*In particular the application does not specify:* 

the height above ground of the proposed floodlights

the hours the proposed lighting will be used

the applicant's definition of winter months.

Wendron Parish Council would look for conditions governing each of these concerns to be imposed on any future permission for development.

It also has concerns about the lumen level of the proposed floodlights.

Accordingly, Wendron Parish Council reserves its position on this particular application and looks forward to considering an amended application in the near future.
