1 APOLOGIES FOR ABSENCE

It was noted that exceptional circumstances have prevented Cllr Mrs Radbone from attending meetings since December. The Clerk reported that she fully expects to be present at the meeting in July.

3 CONFIRMATION OF THE MINUTES OF THE LAST MEETING

Cllr Mrs Moyle proposed, Cllr Mrs Warren seconded, (Cllr Mather, Cllr Mrs Neary and Cllr Tremayne, who were absent from the Annual Parish Meeting, abstained) all others in favour that the minutes of the Annual Parish Meeting held on Monday May 9, 2016 are a true record and the Chairman signed them as being accurate.

Cllr Mitchell proposed, Cllr Mrs Hook seconded, (Cllr Mather, Cllr Mrs Neary and Cllr Tremayne, who were absent from the Annual Meeting, abstained) all others in favour that the minutes of the Annual Meeting held on Monday May 9, 2016 should be adopted as a true record and the Chairman signed them as such.

4 MATTERS ARISING AND NOT COVERED ELSEWHERE IN THIS AGENDA

The Clerk reported that there had been no response from First Group following the Council's request for the positioning of a new bus stop convenient for the Trelill Caravan Park.

Cllr Tremayne reported that Open Access Land at Nine Maidens has recently been fenced and that pigs are presently grazing the area. He further reported that the stream at the eastern end of Polhigey Moor is cutting into the bank and undermining the footpath. The Clerk undertook to deal with both matters.

5 CORNWALL COUNCILLOR'S COMMENTS

CCllr Dr Jenkin reported that

- she has attended a meeting of the Health Scrutiny Committee at which the temporary closure of the Edward Hain Hospital in St Ives had been reported. The closure is consequent upon fire prevention issues, but the maintenance backlog of smaller hospitals throughout Cornwall suggests that other closures may follow
- the Housing Policy of the St Ives Neighbourhood Plan which restricts all new housing to permanent residence has gone through and has prompted a Government Minister to suggest that a change in legislation may be necessary to make Neighbourhood Plans less powerful
- planning permission for conversion of the East Wheal Lovell engine house into a residence has been granted
- Cornwall's refusal of planning permission for the relocation of the wooden houses at Farms Common has prompted an appeal to the Planning Inspectorate.

It was noted that the traffic island at the bottom of Rame Hill needs cutting: in its present overgrown state the lack of visibility for drivers is dangerous.

6 PUBLIC PARTICIPATION

There were no members of the public present.

7 PARISH COUNCIL MATTERS

Neighbourhood Plans

Cllr Mrs Warren reported that matters are slowly progressing

- Cllr Denton is currently contacting businesses with a questionnaire and expects to have answers within the fortnight
- because the original questionnaire contained no child-specific questions, schools are being contacted
- the recent meeting of the Steering Group Committee had been very poorly attended with just two members of the Parish Council (the Chairman and herself) and a representative from Lowertown present
- all members of the Parish Council are invited to attend the next meeting
- Cllr Mather reported that he is three-quarters of the way though a neighbourhood Planning training course: he will present a summary at the next meeting of the Steering Group.

8 PARISH MATTERS

Gateways at Rame/Edgcumbe

Members again considered a proposal to create gateways at either end of the Rame/Edgcumbe stretch of the A394. The Clerk drew members' attention to a drawing supplied by Cornwall Council of a plan for safety measures on the A394 as it passes through Edgcumbe and which is provisionally costed at £50,000. He further reported that Peter Tatlow, the Divisonal Manager, had offered to attend a meeting with representatives of Wendron Parish Council to discuss these works and Parish Council funded enhancements (in the form of stones or planters) which may be possible. The Clerk was asked to contact Mr Tatlow to arrange a meeting

Telephone boxes

The Clerk reported that the replacement door frame for the box at Porkellis had been received and is presently with the carpenter who will be fitting it.

The land at Carnkie

A written report on the meeting which had allowed the residents of Carnkie the opportunity to air their views on the future of this parcel of land had already been circulated to members (a copy of that report is affixed to these minutes). In order to make progress, the Clerk suggested that the Council might consider a proposal to grant delegated powers to the Chairman, to Cllr Mrs Warren and to the Clerk enabling them to make day-to-day decisions relating to this project. Cllr Mather proposed, Cllr Tremayne seconded all others in favour that day-to-day decisions relating to the land at Cankie should be delegated to the Chairman to Cllr Mrs Warren and to the Clerk. Members noted that the Cornwall Wildlife Trust appears keen to offer advice and practical help.

Public Open Space area on the development at Rame Cross

The Chairman reported that the Cornwall Community Land Trust is concerned about the long-term management of the Public Open Space on the new development at Rame Cross. Following discussion, Cllr Mather proposed, Cllr Tremayne seconded all others in favour that Wendron Parish Council would maintain this piece of land in perpetuity if, in a levelled and seeded state, it was gifted to the Council.
