3 CONFIRMATION OF THE MINUTES OF THE LAST MEETING

Cllr Mrs Warren proposed, Cllr Gibson seconded, (Cllr Mrs Hampton and Cllr Maddern, who were absent from the last meeting, abstained) all others in favour that the minutes of the Ordinary Meeting held on Monday January 9, 2017 should be adopted as a true record and the Chairman signed them as such.

4 MATTERS ARISING AND NOT COVERED ELSEWHERE IN THIS AGENDA

There were no matters arising which were not covered elsewhere in this agenda.

5 CORNWALL COUNCILLOR'S COMMENTS

CCllr Dr Jenkin reported that

- the electoral review is ongoing and that it looks as if the recommendation from Cornwall will be for ninetynine Councillors. This would make Cornwall one of the most poorly represented authorities in the country and create problems for rural Councillors simply because of the geographic size of their wards
- the Unitary Authority's proposal to bid for Truro to become the 2023 European City of Culture at an initial cost of £500,000 was mis-reported by the press not least because the proposal was for the whole of Cornwall although centred on Truro. The issue has been called-in by the Scrutiny Committee
- the consultation period for the proposals described in the Sustainability and Transformation Plan which concerns the future delivery of Health Services in Cornwall is drawing to a close. These proposals suggest that more services will be on offer but for less money: for example, there would appear to be a shortfall of £7million in the provision of Adult Social Care
- she had attended the planning appeal hearing concerning the lifting of the agricultural restriction on Tre Wheal, Porkellis. The decision is awaited.

In answer to questions, CCllr Dr Jenkin sympathised with the apparent lack of exchange of up-to-date information

between departments within the Authority. Cllr Gibson cited examples where apparently threatening letters had been sent to people who had died some time ago and which, unsurprisingly, had resulted in dismay.

She confirmed that documents relating to cuts within Children's Services have been released.

6 PUBLIC PARTICIPATION

Referring to Planning Application PA16/12117 Mr George drew members' attention to numerous contraventions of planning rules which have taken place over the past few years at Treloar Farm.

Supporting Mr George, Mr Baxter stated that in their application, the applicants had stated that the access road is in their ownership when that is not strictly correct. He was advised to inform the Planning Authority.

7 PARISH MATTERS

Prouse's Patch

The Clerk reported that he has now received written quotations for the ground-work necessary (which includes the creation of a path and landscaping) to enhance the usability of Prouse's Patch for members of the public both from Rex Andrew and from Bob Sanders. Following discussion, Cllr Mrs Warren proposed, Cllr Mitchell seconded all others in favour to accept Rex Andrew's quotation in the sum of £3,398.00 plus VAT

8 FINANCE

The Clerk presented Members with a statement of Wendron Parish Council's financial position as at February 13, 2017. A copy of that statement is attached to these minutes.

Members considered a request from Edgcumbe Methodist Chapel for financial help towards the upkeep of the cemetery.
