4 MATTERS ARISING AND NOT COVERED ELSEWHERE IN THIS AGENDA

The Chairman reported that the two notices asking motorists not to park on the grass in Carnkie are now in place.

5 CORNWALL COUNCILLOR'S COMMENTS

CCllr Dr Jenkin reported that, since the last meeting, she has

- undertaken a number of induction training sessions: these included Code of Conduct (where she was able to help with the training) and planning
- attended a meeting of the full Council at which John Wood (Independent) was appointed Chairman and Ann Kerridge (Liberal Democrat) Vice-Chairman. The Cabinet now consists of five Independents and five Liberal Democrats
- had a discussion with the newly appointed Network Manager, Maxine Hardy
- both dealt with a number of Highway issues (including PROW 119 at Porkellis Moor and the lane up to Carnkie Village Hall) and toured the area with Tom Marks (who is the Area Manager for West Cornwall)
- had discussions and meetings concerning a number of planning and enforcement issues

- helped with some Nature Workshops at Halwin School (which were grant-funded from her share of the Cornwall Council Community Chest)
- found the Speed Visor at Rame to be working but has nevertheless reported it to Highways who will arrange for the manufacturer to test it. (She is pursuing the promise from Highways of a second Speed Visor for the eastern approach.)

6 POLICE REPORT

Through the Clerk, PCSO Whitford reported that ten crimes (two incidents of theft, two burglaries, two drink driving offences, two assaults, possession of drugs and a complaint against dogs) were reported to the police in May. He warned residents that there has been an increase in rural areas of thefts of domestic heating oil and diesel fuel and asked everyone to make it as difficult as possible for thieves to steal fuel from tanks and vehicles.

7 PUBLIC PARTICIPATION

Mr Perry apologised to members for his long period of absence from meetings and reminded all those present both of the Stithians Show on July 15 and of the Trewennack Show at the end of July.

8 PARISH MATTERS

Trellil Holy Well

Members considered making a donation towards the cost of the work currently being undertaken on Trelill Holy Well in Trewennack. Following discussion, Cllr Davidson proposed, Cllr Mrs Mitchell seconded all in favour to forward a cheque in the sum of £500 to Mrs Ann Preston Jones (who works with the Historic Environment Department at Cornwall Council) to be put towards turf for the roof and re-pointing the inner walls with any sum remaining to be devoted to the compilation and printing of a poster for the Helston Museum.

The purchase and position of a defibrillator

Members again considered the purchase and siting of a defibrillator. It was agreed to ask Wendron Cricket Club if the board of Trustees would be receptive to positioning a defibrillator in the Club House.

The purchase of a notice-board for Edgcumbe

Cllr Mitchell reported that, following informal discussion, a site in the hedge of the field adjoining the church had been identified as being suitable. The Clerk was asked to liaise with Cornwall Highways about the position and to obtain a quotation for the making and erection of a notice-board at this point.

The repair or replacement of the gate into Wendron cemetery

The Clerk reported that he had asked Mr Tristan Kessell to quote for the repair of the gate into Wendron cemetery (if in his opinion that could be done), for a replica of the existing gate and for an entirely new gate with a design of his creation. He has also asked Mr Richard Hingley, the blacksmith at Mawnan, to supply similar quotations. Members were widely in favour of replicating the existing design and, a quotation for this work having been received from Mr Kessell, the Clerk was asked to liaise with Rev'd David Miller and the Parochial Church Council.

9 PARISH COUNCIL MATTERS

Co-option of Councillors

The Clerk reported that he had received expressions of interest in standing for co-option as Parish Councillors from Mr Andrew Tremayne, Mr Geoff Gibson and Mr Richard Maddern.

Cllr Mitchell proposed, Cllr van den Berg seconded all others in agreement that Mr Gibson should be co-opted as a Parish Councillor.

Cllr Davidson proposed, Cllr Mrs Moyle seconded all others in agreement that Mr Tremayne should be co-opted as a Parish Councillor.

Cllr Mrs Moyle proposed, Cllr Mrs Mitchell seconded all others in agreement that Mr Maddern should be co-opted as a Parish Councillor.

The Chairman welcomed back Cllr Gibson, Cllr Tremayne and Cllr Maddern as members of Wendron Parish Council.

10 FINANCE
