# 5 CORNWALL COUNCILLOR'S COMMENTS

CCllr Dr Jenkin reported that

- she is pleased to note that the Rame Croft development has been signed off. Work is scheduled to begin in January/February and will take a year
- the access from the A394 to the HX1 site was decided using delegated powers. She has registered clear concerns
- Halwin School will become a member of the Southerly Point Co-operative Multi-Academy Trust as from the beginning of February
- the Headteacher at Halwin School has been appointed to a new post and consequently will be leaving at the end of the Spring Term
- the Cornwall Local Plan has been approved and the policies contained therein should be adhered to in the planning process
- along with Cllr Mitchell, she had attended the Traffic Order Meeting called by Helston Town Council. It would appear that anything at all 'difficult' will be omitted from the application

Following discussion, it was proposed by Cllr Gibson, seconded by Cllr Mrs Moyle all others in favour that the Precept for the year 2017/2018 should be set at £33,000 and that it should be noted that the year-on-year increase is largely due to Cornwall Council's proposed recharge for a contested election of the Parish as a whole of £6,469.64

Members considered a request from the Trewennack Horticultural Show Committee for financial help towards the cost of the purchase of new chairs. Following discussion, Cllr Davidson proposed, Cllr Mrs Mitchell seconded and it was agreed that, under the terms of Section 137 of the Local Government Act 1972, Wendron Parish Council should forward the sum of £250.00 to the Trewennack Horticultural Show.
