Minutes of the Annual Meeting of Wendron Parish Council held in the Community Hall, Burras on Wednesday May 9, 2018 immediately following the end of the Annual Parish Meeting.

The Chairman welcomed members and visitors to the Annual Meeting.

1 ELECTION OF CHAIRMAN

Cllr Mrs Neary proposed, Cllr Mitchell seconded and it was agreed that Cllr Mrs Moyle be elected to the Chair of Wendron Parish Council for the year 2018 - 2019.

2 CHAIRMAN'S DECLARATION OF ACCEPTANCE OF OFFICE

Cllr Mrs Moyle read aloud, signed and dated the statutory Declaration of Acceptance of the Office of Chairman of Wendron Parish Council for the year 2018 – 2019 in the presence of the Council and Clerk.

3 ELECTION OF VICE-CHAIRMAN

Cllr Mrs Moyle proposed, Cllr Durkin seconded and it was agreed that Cllr Mrs Neary be elected to the post of Vice-Chairman for the year 2018 – 2019.

4 APOLOGIES FOR ABSENCE

Apologies for absence were received from Cllr van den Berg, Cllr Davidson, Cllr Ferris and Cllr Tremayne.

5 DECLARATIONS OF INTEREST

6 CONFIRMATION OF MINUTES OF PREVIOUS MEETING

Cllr Mrs Neary proposed, Cllr Mitchell seconded and it was agreed that the minutes of the meeting held on Monday April 9, 2018 are a true record and the Chairman signed them as such.

7 MATTERS ARISING AND NOT COVERED ELSEWHERE IN THIS AGENDA

Cllr Durkin reported the award from the National Lottery of a grant of £10,000 to Halwin Pre-School towards the purchase and installation of an outdoor classroom.

8 PUBLIC PARTICIPATION

Mr Mitchell stated that he was present to seek the Parish Council's support for Planning Application PA18/03299 for extensions to Moorland View House. He explained that there are three elements to the application: the creation of a slightly larger conservatory, the re-configuration of the room above the garage (for which there is extant permission) and the construction of a summer-room at the rear of the house.

Mr Jump said that he and his wife were present to ask if there is anything that can be done to slow traffic as it passes through Penmarth. If a speed limit cannot be imposed he suggested that thought should be given to the installation of warning signs. One suggestion that was made involved moving the village sign a little further to the east and adding the words 'Please drive carefully through our village'.

Mr Lea of Viscar Lodge outlined his plans for the establishment of a wild-life area on fields which he owns in Carnkie. This will include the creation of ponds and a wild-life tower. He invited anyone interested to call in when he would show them what he intended.

9 CORNWALL COUNCILLOR'S COMMENTS

CCllr Dr Jenkin reported that

- notifications of potholes on roads in Cornwall are currently being received by Cormac at the rate of one hundred a day. Possibly unsurprisingly, the Highways Authority is struggling to meet its target of repairing reported potholes in rural areas within seventy-two hours. Cormac does however have the use of three state-of-the-art vehicles that can do the necessary job quickly and effectively
- each Community Network area now has access to a Highways' pot of £50,000. In Helston and the Lizard the intention is to use this money to fund those projects identified in the emerging Traffic Regulation Order. Nevertheless, she thought it might be worthwhile, even at this late stage, to ask for the inclusion of yellow no waiting lines at the bus-stop pull-ins in Rame
- the Council may like to consider making the case for individual buildings to be included on the register of Assets of Community Value
- the foundations for the new Wendron Pre-School building are now in place and it is anticipated that construction will commence during the summer holiday
- she does not approve of the fact that Cornwall Council's Capital Reserve is being used to build roads
 to ensure large-scale development, for example at the Duchy development in Newquay. Similarly, the
 Council intends funding capital projects for use by the community on land being developed
 commercially in Truro. In such instances she feels the developers should be required to underwrite the
 associated costs.

10 STANDING ORDERS

Cllr Mrs Moyle proposed and it was agreed that Wendron Parish Council should re-adopt Standing Orders as fully revised in August 2007 and further revised in August 2009, September 2010 and May 2011. It was further agreed that Standing Orders should be discussed with a view to revision at the meeting in June.

11 FINANCIAL REGULATIONS

Cllr Mrs Moyle proposed and it was agreed that Wendron Parish Council should re-adopt Financial Regulations last substantially revised in October 2014. It was further agreed that Financial Regulations should be discussed with a view to revision during the course of the coming year.

12 RISK ASSESSMENT

Cllr Mrs Moyle proposed and it was agreed that Wendron Parish Council should re-adopt the Risk Assessment document as last substantially revised in October 2010. It was further agreed that the Risk Assessment document should be discussed with a view to revision during the course of the coming year.

Cllr Mrs Moyle proposed and it was agreed to insure Wendron Parish Council through AXA Insurance UK plc and to pay the premium demanded of £988.17

Members noted that Wendron Parish Council will self-insure all its assets other than those listed on the schedule during the year to May 31, 2017.

Wendron Lawn Cemetery

Members considered an offer from Mr Chris Bond to site a granite bench in memory of his wife in the Lawn cemetery against the southern hedge. Expressing his thanks for this very generous offer Cllr Mrs Moyle proposed and it was agreed that Wendron Parish Council should accept Mr Bond's kind offer.

15 PARISH MATTERS

A defibrillator for Menherion

Members considered a request from the residents of Menherion to underwrite the capital cost of a public access defibrillator. Following a brief discussion Cllr Mr Moyle proposed and it was agreed that Wendron Parish Council should install a defibrillator unit for use whenever necessary on an exterior wall of the Golden Lion.

Footpath along the southern causeway of Stithians Lake

The Clerk reported that Cornwall Council has asked the Council to identify what it feels is the most appropriate route for the proposed footpath along the southern causeway and it was agreed that this should be done informally following the end of the meeting.

16 FINANCE

The Clerk presented Councillors with a statement of Wendron Parish Council's financial position as at May 9, 2018. A copy of that statement is attached to these minutes.

Members considered a request from Victim Support for help with funding the cost of the work done to support victims and witnesses of crime in Cornwall. It was proposed by Cllr Mrs Neary, seconded by Cllr Mrs Borman and it was agreed that, under the terms of Section 142(2A) of the Local Government Act 1972, the sum of £100 be forwarded to Victim Support to help fund their work in Cornwall.

Members considered a request from Mr Henry Wedlake for financial help towards the cost of a mining trip to South Africa to gain experience in shaft sinking relevant to the mining engineering course he is presently undertaking. Following considerable discussion, it was agreed that under the terms of Section 137 of the Local Government Act 1972, the sum of £50 be forwarded to Mr Henry Wedlake.

The Clerk reported that Mr Peter Richards, Wendron Parish Council's Internal Auditor, has signed off the Annual Return for the year to March 31, 2018 making no comments, observations or suggestions.

Parish Councillors considered the Statement of Assurance required for the Annual Return for the year ended March 31, 2018. Cllr Mrs Moyle proposed, Cllr Mitchell seconded and it was agreed that Wendron Parish Council should answer "Yes" to each of the questions posed by the Statement of Assurance which forms part of the Annual Return for the year ended March 31, 2018.

The Clerk presented the accounts for the year April 1, 2017 – March 31, 2018. Cllr Mrs Borman proposed, Cllr Durkin seconded and it was agreed that Wendron Parish Council accepts and approves the accounts for the year April 1, 2017 – March 31, 2018.
