Minutes of the Ordinary Meeting of Wendron Parish Council held on Monday December 10, 2018 at 7:30pm at Penmarth Methodist Sunday School.

The Chairman welcomed members and visitors to the December meeting.

1 APOLOGIES FOR ABSENCE

Cllr Davidson, Cllr Ferris, Cllr Mrs Hampton, Cllr Mitchell, Cllr Stevens and Miss Weston all sent their apologies for absence.

2 DECLARATIONS OF INTEREST

in items on the agenda

Cllr van den Berg declared a registrable interest in Agenda Item 10 PA18/07707

of gifts (received as a result of being a member of the Council) of a value greater than £25

There were no declarations of gifts of a value greater than £25.

3 CONFIRMATION OF THE MINUTES OF THE LAST MEETING

Cllr Durkin proposed, Cllr Mrs Borman seconded and it was agreed that the minutes of the Ordinary Meeting held on Monday November 12, 2018 are a true record and the Chairman signed them as such.

4 MATTERS ARISING AND NOT COVERED ELSEWHERE IN THIS AGENDA

The Chairman reported that a road sign on the corner by the Star Inn in Porkells has been knocked down. She further reported that a low fence has been erected between the houses at Trinity Close and Trinity Praze which effectively prevents very young children from accessing the play area. The Clerk undertook to follow both these issues through.

5 CORNWALL COUNCILLOR'S COMMENTS

CCllr Dr Jenkin reported that

- the recent full Cornwall Council meeting had included debates on
 - 1. the very real danger to life and limb for children who have to walk either to school or to bus stops along busy rural roads (for example at Farms Common)
 - 2. a call to support a so-called "peoples' vote" in the matter of Brexit
 - 3. an inconsistent approach from planning enforcement officers throughout Cornwall when divulging sensitive information about individual cases to Ward Members
- the Health and Adult Social Care Committee continues to grapple with the problems of adequately funding the department. The recently announced increase in the Central Government Grant is only just sufficient to keep up with increasing numbers of people in need, but the service is already so far stretched that it is close to breaking-point
- she has been speaking to planning officers about the proposed canine crèche business on the Helston Road and in particular about what has been happening on the site as a whole (which is the subject of a planning enforcement allegation)
- the Crowan Neighbourhood Development Plan is ready for submission and contains a paragraph concerning

the removal of historic hedges from building sites and which presently is considered to be permitted development. Crowan considers that they help make up the character of both the World Heritage Site and the Area of Great Landscape Value (and Wendron might like to consider including a similar paragraph in any document it produces)

• because the sluices were shut in the summer, the Helston leats dried out and are now leaking – and there is no money for their repair. The days when a man was employed to keep them clear and to deal with any problems have long gone. South West Water, which was responsible for shutting the sluices, bears some responsibility in the matter as does the Environmental Agency. Both organisations will be invited to a future meeting to discuss the issue.

In answer to questions, CCCllr Dr Jenkin said that

- the concerns expressed by Miss Weston about trees growing in the upper reaches of the Cober might be addressed by the Upstream Catchment Management team
- the Tri-Service project, which is designed to provide a supportive link between Devon & Cornwall Police, Cornwall Fire, Rescue and Community Safety Service, the South Western Ambulance Service NHS Foundation Trust and Cornwall Council's Anti-Social Behaviour Team is still in its infancy and remains an aspiration for South Kerrier.

6 PUBLIC PARTICIPATION

There were no comments from members of the public.

7 PARISH MATTERS

Carnkie Play Area

Members again noted that the Play Area lease is currently with the Council's solicitors who are working to extend the term of tenure. Cllr Durkin reported that there may be interest from residents in helping to raise funds for new play equipment.

Prowse's Patch

Members noted that, weather permitting, Bob intends to create the short access path and to have the bench installed within the course of the week.

A defibrillator for Trewennack

Members noted that the Clerk had liaised with the Friends group in Trewennack over this matter and had received a contribution from them in the sum of £700. Cornwall Council has intimated not only that it will put two posts in place (to carry the unit) but also that it will supply and pay for any electricity the unit will use. Tom Salkeld, who is a member of the Friends, has agreed to make a board on which to house the unit ... and the project seems to be well on the way to fruition.
