Minutes of the Ordinary Meeting of Wendron Parish Council held on Monday January 14, 2019 at 7:30pm at Penmarth Methodist Sunday School.

3 CONFIRMATION OF THE MINUTES OF THE LAST MEETING

Cllr Durkin proposed, Cllr van den Berg seconded, Cllr Ferris, Cllr Mrs Hampton, Cllr Mitchell and Cllr Stevens who were absent from the last meeting abstained and it was agreed that the minutes of the Ordinary Meeting held on Monday December 10, 2018 are a true record and the Chairman signed them as such.

4 MATTERS ARISING AND NOT COVERED ELSEWHERE IN THIS AGENDA

Cllr Stevens reported that fencing around the severely damaged bungalow in Carnkie has been removed and that consequently children from the village are beginning to explore the ruins. This is clearly a dangerous pursuit and the Clerk was asked to contact Cornwall Council with a view to requesting that the fence be replaced.

Members noted two or three instances of anti-social behaviour within the Parish: the police have been informed.

The Clerk was asked to report a deep pot-hole on the road south of Menherion.

5 CORNWALL COUNCILLOR'S COMMENTS

6 PUBLIC PARTICIPATION

There were no comments from members of the public.

7 PARISH MATTERS

Carnkie Play Area

Members noted that the Play Area lease is still with the Council's solicitors, who anticipate that the document will be ready for signature within the next fortnight.

Prowse's Patch

Members noted that Bob Sanders and his team have created the short access path and have installed the new bench. The Council has already been thanked for the facility.

A defibrillator for Trewennack

Members noted that the Clerk had met with Jon Borlase of SSE Contracting who, at the request of Cornwall Council, had undertaken to install the two posts and a link to the electricity supply and that the order has been placed for the defibrillator and the cabinet. The posts have since been installed, the back-board is in place and all would appear to going smoothly.

Neighbourhood Plans

Cllr Ferris had nothing to report.

Public Rights of Way

Members considered seeking Modification Orders on PROW 117 (to join Prow 115) and on PROW 89 (to join the road). Following discussion, Cllr Durkin proposed, Cllr Mitchell seconded and it was agreed to pursue both issues.

8 PARISH COUNCIL MATTERS

Co-opted members

The Clerk reported that interest in standing for co-option as a Parish Councillor has been expressed by Mr Paul Swain.

Mr Swain left the room while this matter was in progress.

Following a short discussion, The Chairman proposed, Cllr Mitchell seconded and it was agreed that Mr Swain should be co-opted as a Parish Councillor.

Mr Swain was invited to return to the room.

Cllr Swain signed and read aloud his declaration of acceptance of office before Mr Chapman, Clerk to Wendron Parish Council, the Proper Officer. The Chairman welcomed Cllr Swain as a member of Wendron Parish Council.

Community Governance Review – Parish Boundaries

Members considered whether or not there are any issues relating to the governance of the Parish or its boundaries which need to be addressed in order to bring it in line with change. Following a short discussion, it was agreed that the historic boundary should be retained, that there is a need for the number of Councillors to be reduced (possibly to eleven) and that there is an argument for 'de-warding' the Parish.

Members noted a net payment of £1,306.00 to the Ronnie Richards Memorial Charity in respect of the purchase of a defibrillator for Trewennack (payment authorised under agenda item 7 November 12, 2018).

Members considered making a donation towards the Sowenna Appeal which, at its new facility in Bodmin, will support young people from across Cornwall who are suffering severe mental illnesses. Following discussion, the Chairman proposed, Cllr van den Berg seconded and it was agreed to forward the sum of £500 to the Sowenna Appeal under the terms of \$137 of the Local Government Act 1972.

10 PLANNING

Applications

PA18/11065 – Dr John Collier – Installation of 250mm pipeline alongside existing 600/710mm pipeline to supply water to a micro hydro-electric scheme, in existing powerhouse – Trelubbas Wartha Farm, Lowertown. Cllr Ferris proposed, Cllr Stevens seconded and it was agreed that this application should be returned with the following observation *Wendron Parish Council supports this application*.

PA18/11570 Mr P.Cramb – Application for the refurbishment and first floor extension to farmhouse together with conversion of barns to holiday accommodation – Medlyn Moor Farm, Porkellis. The Chairman proposed, Cllr Durkin seconded and it was agreed that this application should be returned with the following observation *Wendron Parish Council supports this application*.

PA18/11819 Mr S.Burke – Proposed conversion of two barns to a single dwelling with linking extension and conversion of further barn to a detached annexe and associated works, including the siting of temporary caravan during the build period – Moorstone, East Calvadnack, Carnmenellis. Cllr Ferris proposed, Cllr Buckingham seconded and, with one abstention, it was agreed that this application should be returned with the following observation Wendron Parish Council notes that Policy 7 of the Cornwall Local Plan states that new dwellings in the countryside will be restricted to the 'reuse of suitably constructed redundant, disused or historic buildings that are considered appropriate to retain and would lead to an enhancement of the immediate setting'. Wendron Parish Council does not consider that this proposal would meet the requirements set out in this policy because it would not result in the 'enhancement' of the immediate setting due to the nature of the construction of the existing agricultural building (which is of single block). Development would bring car parking and all the domestic paraphernalia associated with residential use which would appear out of place in this location. Wendron Parish Council believes that the negative impact of a new residential development at this location would harm the rural setting and that that would not be outweighed by any resulting economic benefit to the community. Accordingly, Wendron Parish Council requests the Planning Authority to refuse permission for development.
