3 CONFIRMATION OF THE MINUTES OF THE LAST MEETING

Cllr Durkin proposed, Cllr Mrs Borman seconded, Cllr van den Berg who was absent from the meeting abstained and it was agreed that the minutes of the Annual Parish Meeting held on Thursday May 13, 2019 are a true record and the Chairman signed them as being accurate.

Cllr Mitchell proposed, Cllr Swain seconded, Cllr van den Berg who was absent from the meeting abstained and it was agreed that the minutes of the Annual Meeting held on Thursday May 13, 2019 are a true record and the Chairman signed them as such.

4 MATTERS ARISING AND NOT COVERED ELSEWHERE IN THIS AGENDA

Cllr Durkin reported that he had attended the speed event at County Hall at which Chief Inspector Adrian Leisk had outlined the various initiatives which are in place throughout Devon and Cornwall. At that meeting, Cllr Durkin had stated that he and others living locally had registered an interest in becoming involved, but that, as yet, they had heard nothing. He had written in similar vein to Alison Hernandez, the Police and Crime Commissioner for Devon and Cornwall, again without result. Members noted that Speed Cameras are gradually being replaced, but that there is currently a lack of funding. Members further noted that individual members of the public are invited to forward videos of incidences of dangerous driving to the police under a new initiative, Operation Snap – although Cllr Binnie suggested it might be better either to pass such evidence to the local PCSO or hand it in at a police station. Members noted that there have been three road traffic incidents on the Carnkie to Carnmenellis road within the last fortnight.

5 CORNWALL COUNCILLOR'S COMMENTS

CCllr Dr Jenkin reported that

- the Planning Enforcement department is close to a decision concerning the Mono Construction site at Carnkie. She suggested that the Council may like to write to Enforcement about the matter
- the Health and Social Care sub-committee is currently very quiet: behind the scenes, work on issues surrounding networks and localities is progressing

- the recent full Meeting of Cornwall Council had declared a Climate Emergency whilst elsewhere, Cornwall has offered £12 million from its capital fund towards the costs involved in setting up the Space Port. This latter offer is subject to approval from the full Council and questions concerning quite how the County as a whole will benefit are sure to be asked
- the question of the leats and quite who is responsible for the maintenance of this Victorian infrastructure is under discussion
- Cornwall is seeking the views of residents concerning the Climate Emergency through an on-line survey. The Clerk undertook to put a link to this survey on the Parish Council's website.

7 PARISH MATTERS

Carnkie Play Area

Members noted that the extension of the Play Area lease is close to being ready for signature. Mr Cruikshanks' solicitor had raised concerns about two clauses within it concerning matters of insurance, both of which have since been clarified with Came and Company (which acts as the Council's insurance broker). Following discussion, Cllr Durkin proposed, Cllr Mrs Moyle seconded and it was agreed that Mr Cruikshanks' interest as the landlord of Carnkie Play Area should be noted on Wendron Parish Council's insurance policy. Following further discussion, Cllr Stevens proposed, Cllr Mitchell seconded and it was agreed to appoint the Chairman and the Clerk to sign the extension to the lease on behalf of Wendron Parish Council.

Neighbourhood Plans

Cllr Mrs Borman reported that the advisory committee would like suggestions and amendments to the proposed community questionnaire returned as a matter of some urgency. Members of the advisory committee will attend a training session with Cornwall Council on Wednesday June 19 and are keen to move the process forward.
