Minutes of the Ordinary Meeting of Wendron Parish Council held on Monday December 9, 2019 at 7:30pm at Penmarth Methodist Sunday School.

The Chairman welcomed members and visitors to the December meeting.

### 1 APOLOGIES FOR ABSENCE

# 3 CONFIRMATION OF THE MINUTES OF THE LAST MEETING

Cllr Durkin proposed, Cllr Mitchell seconded, Cllr Binnie, Cllr Mrs Borman, Cllr Looker and Cllr Swain who were absent from the last meeting abstained and it was agreed that the minutes of the Ordinary Meeting held on Thursday November 11, 2019 are a true record and the Chairman signed them as such.

# 4 MATTERS ARISING AND NOT COVERED ELSEWHERE IN THIS AGENDA

The Chairman suggested that a short resumé of progress made by steering groups should be forwarded to members before every meeting and particularly so when members of the steering group are intending to be absent.

Cllr Binnie reported that he had attended a meeting at the Golden Lion, which had been called by Stithians Parish Council, to consider problems relating to South West Water's management of sewage. It was stated that raw sewage from the pipe which commences in the Parish of Wendron frequently spills from the pipe onto the road in the village of Stithians. In the absence of action by South West Water, Wendron Parish Council was asked to be aware of the problem when considering planning applications within the parish.

# 5 CORNWALL COUNCILLOR'S COMMENTS

CCllr Dr Jenkin reported that

- she had attended the full Council budget briefing at which it had become clear that the delivery of all non-statutory services is becoming financially problematic
- this problem stems from ever increasing demands on the Health and Social Care Service budget which are not being underwritten by Central Government
- when she started work as a Cornwall Councillor in 2011, the Central Government grant had been in excess of £500m: it will be just £43m in the coming financial year
- the widely reported capital expenditure on the Newquay Space Port will be spent on assets owned by

- Cornwall Council, such as the runway and service buildings as well as at Goonhilly, where high quality jobs will result
- the Governance and Boundary Review Panel's recommendations are, as far as Wendron is concerned, being ignored. The proposals before the full Council tomorrow are representative solely of Helston Town Council's acquisitive nature: CCllr Dr Jenkin was prevented from adding any counter proposals because she was indisposed. If Wendron is to retain its present boundaries, it is important that, when the issue goes out for public consultation, there is a good response from residents
- it has become apparent that the improvements to the Helston/Redruth road have been heavily diluted. Cornwall Highways argues that government guidelines for the imposition of speed limits are not met in the settlements along the road and that therefore there is nowhere that needs a speed limit review. However, consideration is being given to the provision of 'gateway' schemes. CCllr Dr Jenkin called for evidence (in particular photographs) of places where a speed limit is in place in an area which does not conform to government guidelines
- she had attended a recent Flood Forum meeting at which South West Water's response to the problems in Stithians had not impressed attendees
- she still has a portion of her share of Community Chest funding for distribution.

# 6 PUBLIC PARTICIPATION

PC Mark Mitchell introduced himself as the newly-appointed Beat Manager adding that he and PCSO Julia Berry now have responsibility for the rural areas. He suggested that the major concern in most rural areas is the inappropriate use of speed and regretted the unavoidable cancellation of the Community Speed Watch Meeting. To date, a single site (in Carnkie) has been identified (and is shortly to be authorised) as a location where a Speed Watch team can operate in safety. It has not yet been agreed whether teams should be composed of Kerrier-wide or parish based volunteers. Once the teams are trained and working, the Police will join them for their first three outings after which they will operate on a stand-alone basis. Instances of crime within the parish are few: the major issue presently is the number of untaxed and uninsured vehicles on the roads. PC Mitchell suggested that members and residents might like to sign up to the Devon and Cornwall Alert Community Messaging System and added that the best way to get in touch with the Neighbourhood Team is by using the on-line form.

#### **Parish Notice-Boards**

# **Publicity**

Members noted that the Wendron Parish Council FaceBook page, although up and running, is inaccessible to followers. Cllr Looker kindly agreed to correct this.

# Community Network Panel's Highways Scheme 2020/2021

Members agreed to seek Traffic Regulation Orders to forbid parking at the corner of Penmeneth in Trewennack and on the road outside Wendron School where a 20mph speed restriction will also be sought. They further agreed to seek the extension of double-yellow lines from the corner opposite Rame Post Office, the extension of the 40mph speed limit to a point north of Park Pedrek and the creation of a virtual footpath along Rame Hill between the Post Office and Park Pedrek.

# **Neighbourhood Plans**

It was noted that a revised questionnaire has yet to be written. Following considerable discussion, it was agreed that members should review the existing questionnaire and bring any comments they might have to the meeting in January when the final format will be agreed. It was further agreed to make a provisional enquiry for the use of a table in the Community Tent at the Stithians Show, where residents' opinion on proposals made following collation of the results of the questionnaire would be sought.

#### 9 FINANCE

Members were presented with a statement of Wendron Parish Council's financial position as at December 9, 2019. A copy of that statement is attached to these minutes.

Members noted that the Clerk had earlier forwarded copies of anticipated income and expenditure of Wendron Parish Council for the coming Financial Year..
