6 CORNWALL COUNCILLOR'S COMMENTS

CCllr Dr Jenkin reported that

- Covid 19 briefings: Cornwall Council has converted to response mode to deal with the serious situation during lockdown and members have been having regular weekly briefings to ensure they are all aware of the latest developments
- vaccinations are now rolling out in all areas and include the regional hub at Stithians Show Ground
- further information on Covid-19 data can be found on Cornwall Council's and Central Government's websites
- she has attended a number of meetings concerning environmental strategies, water management and flooding

- residents living in Trenear are at risk of the River Cober over-topping its banks. The situation is constantly monitored and, in addition to residents having access to relevant officers, there may be funding available in the near future for capital work to protect against damage
- members' allowances were discussed at a recent meeting of the full Council and a proposal to support the Independent Panel's recommendations for a small increase was lost
- the Health and Adult Social Care Overview and Scrutiny Committee, of which she is a member, had considered the results of the consultation on the Draft Policy on Adult Social Care charging and had recommended it to Council
- a meeting of the Standards Committee had looked at the current consultation on the revisions to the Member Code of Conduct and organisational complaints considered by the Council and the Local Government and Social Care Ombudsman
- the Neighbourhoods Committee has recommended additional resources for the Fire and Rescue Service to increase capacity in dealing with Fire safety reviews
- as our Cornwall Councillor, she had attended the recent Community Network Panel meeting. Items covered had included reports from the Police and RNAS Culdrose as well as a presentation on Social Prescribing which is providing a prescription via the GP surgery to encourage people to make changes to their lifestyle and take actions to improve their health outcome
- notices of the forthcoming election will be posted on March 22, nomination papers must be deposited with Cornwall Council by March 29. The Clerk was asked to request that nomination papers might be deposited at Dolcoath Avenue rather than at Penzance.

In answer to a question concerning the future of Tregilly Cottage in Trewennack, CCllr Dr Jenkin stated that, as yet, she had heard nothing further about the proposals put forward last year.

7 PUBLIC PARTICIPATION

There were no members of the public present.

8 PARISH COUNCIL MATTERS

Public Rights of Way

Members considered an invitation from Cornwall Council to continue with the Local Maintenance Partnership scheme. The grant offered for the year to March 31, 2022 is £6,335.06 (or 100% of eligible costs, whichever is the lower). The Chairman proposed, Cllr Mrs Borman seconded and it was agreed that Wendron Parish Council should accept Cornwall Council's invitation to renew partnership working.

9 PARISH MATTERS

Publicity

In the absence of Cllr Durkin there was no report. Cllr Looker said how impressed he had been with the way in which Cllr Durkin had tackled the complexities of Facebook and it was unanimously agreed that the Council as a whole is much in his debt.

Carnkie Play Area

Members noted that, following an adverse report from RoSPA, the climbing frame in Carnkie Play Area has been condemned and will be removed. The question of its replacement was considered and, following discussion, the Chairman proposed and it was provisionally agreed to replace the climbing frame with a 'Sputnik' roundabout for younger children and a pendulum swing for older youngsters. These will be supplied and installed by Wicksteed Play at an estimated cost of £15,000. However, it was agreed to give residents the opportunity to have their say by advertising the proposal on the Council's Facebook page. In the meanwhile, the Clerk was asked to seek a firm quotation for the installation of these two pieces of equipment.

Cllr Ferris asked if consideration might be given to the provision of play equipment in Penmarth particularly as there is a designated play are in Trinity Close. The Clerk undertook to speak to Coastline about his possibility.

10 FINANCE

11 PLANNING

Members noted that the following planning applications had been received and considered and that the appended observations had been returned to the Planning Authority using delegated powers

PA21/00100 Mr and Mrs S.Davis – Loft conversion and erection of an extension – Chywarton, Trevenen Bal Wendron Parish Council supports this application.

PA21/00134 Truro Diocesan Board of Finance – Construction of 3 no. residential dwellings and associated development – land adjacent to The Vicarage, Wendron. Wendron Parish Council does not support this application. The plan for three infill, open-market homes set on small plots at right-angles to the road is at odds with the character and distinctiveness of the village as a whole and of this area in particular and is therefore contrary to Policy 3 of the Cornwall Local Plan. The site, in common with the village of Wendron as a whole, is set in an unsustainable location and occupancy of these homes would both necessitate the use of a private motor vehicle and lead to an increase in the volume of delivery traffic. The economic benefit deriving from development would be minimal and would not outweigh the harm done to the existing character of the village. Wendron Parish Council requests the Planning Authority to refuse permission for development.

PA21/00140 Mr Taylor – Two storey extension – Trevilges Farm, An Skyber, Trewennack, Wendron Parish Council supports this application.

PA21/00633 Cornwall Energy Recovery Ltd – Non material amendment in respect of decision K167(1) to temporarily amend the approved operating hours for a period of five weeks to permit the opening of the site to members of the public until 18:00 hours followed by a 30 minute period to allow site staff to close and exit the site for five consecutive Wednesdays from Wednesday 3rd March 2021 up to and including Wednesday 31st March 2021 – Helston Refuse Centre, Gays Hill, Helston. Wendron Parish Council supports this application. (Members noted that this application has since been withdrawn.)

Applications

PA21/00749 Mr M.Long – Proposed garage extension including small roof terrace – 1 Rame Croft. The Chairman proposed Cllr Looker seconded Cllr van den Berg abstained and it was agreed that this application should be returned with the following observation Wendron Parish does not support this application, The proposal is for an extension on the front elevation of the existing dwelling which would alter the existing open and linear nature of the street scene and would therefore be at odds with the character and distinctiveness of Rame Croft contrary to Policy 23 of the Cornwall Local Plan. Wendron Parish Council requests the Planning Authority to refuse permission for development.

12 REPORT OF CLERK AND CORRESPONDENCE

The Clerk reported that the Vehicle Activated Speed sign in Trewennack is due for replacement. Bearing in mind the existing Average Speed Cameras, the replacement of this sign would seem unnecessary and he had asked Cornwall Council to consider siting any replacement in Carnkie where there are on-going concerns about speeding through the village. CCllr Dr Jenkin had supported this proposal, but it remains to be seen whether or not Cornwall Highways will undertake this work.

The new notice-board for the Park an Daras development is due to be delivered tomorrow and will be installed in the near future

13 CHAIRMAN'S AND COUNCILLORS' COMMENTS

The Chairman reported that she had no comments, but that Cllr Mitchell had reported that the VAS sign near the Halfway House has now been repaired and was in full working order. He sent his thanks to the Clerk.

Cllr Mitchell has identified a new space for the Rame notice-board following its removal to accommodate the defibrillator. The Clerk was asked to instruct Bob Sanders to do the necessary work.

Cllr Mrs Borman and Cllr Ferris reported that work on the Neighbourhood Plan has stalled for the moment.

In answer to a question, the Clerk confirmed that the bench at Burras has been removed for repair: it will be replaced.
