Minutes of the Annual Meeting of Wendron Parish Council held in Penmarth Methodist Sunday School on Monday May 17, 2021 immediately following the end of the Annual Parish Meeting.

The Chairman welcomed members and visitors to the Annual Meeting.

1 ELECTION OF CHAIRMAN

Cllr Durkin proposed, Cllr Mitchell seconded and it was agreed that Cllr Mrs Moyle be elected to the Chair of Wendron Parish Council for the year 2021 – 2022.

Cllr Mrs Moyle read aloud, signed and dated the statutory Declaration of Acceptance of the Office of Chairman of Wendron Parish Council for the year 2021 – 2022 in the presence of the Council and Clerk.

5 CONFIRMATION OF MINUTES OF PREVIOUS MEETING

Cllr Durkin proposed, Cllr Mrs Borman seconded and it was agreed that the minutes of the meeting held using the Zoom facility on Monday April 12, 2021 are a true record and the Chairman signed them as such.

6 MATTERS ARISING AND NOT COVERED ELSEWHERE IN THIS AGENDA

There were no matters arising which were not covered on the agenda.

7 PUBLIC PARTICIPATION

Mr Davie stated that he was present to seek the Parish Council's support for his application at Trelill. Having told Councillors a little of the history of the settlement of Trelill, he reminded them that he had created a residential property from the existing barn and confirmed that the new site is part of his property. His plans are for a small single storey home faced with some of the stone saved from the old farm buildings which, he said, would be in keeping with the barns across the road.

8 CORNWALL COUNCILLOR'S COMMENTS

CCllr Dr Jenkin reported that

- she is very pleased to have been elected as the local member
- she had met with the Highways Officer in Rame and that he had recognised the danger posed in crossing the road at the corner. While they were there, a number of vehicles had turned off the A394 at speed and there is now a possibility that not only will the virtual footpath be constructed on the eastern

side of the road as the Council had requested, but also that the western corner will be built out to slow traffic turning off the A394

- she has spoken to Andrew George about the lack of adherence to the approved plans for Park Pedrek. There are steps down the path to the road rather than a slope, which means that prams, pushchairs and toddlers' on bikes have to use the road to exit the estate
- there is certainly a strong argument in favour of limiting vehicle speed on rural roads throughout the county and, possibly, it should be looked at again
- it is essential for all individuals with an interest in lowering the speed limit to record all incidents of which they become aware: near misses, minor accidents, the more comprehensive a list, the more likely that something will eventually be done

Cllr Mitchell reported both that cars are being parked in the bus pull-ins in Rame and that the flashing 40mph sign near The Halfway House appears to set at well over the legal limit. He also wondered what if anything was being done about the informal car sales from Lestraynes Lane.

It was noted that children's play equipment was installed at Fleur de Lys during the course of 2019 and that the Planning Enforcement team does not appear to have taken the matter of the residential park homes any further.

Concerning walking along the road in rural areas, Cllr Durkin reported that a Road Safety Unit has been set up as a unit of the Cornwall Countryside Access Forum.

9 ELECTION OF VICE-CHAIRMAN

Cllr Mrs Moyle proposed, Cllr Mitchell seconded and it was agreed that Cllr Durkin be elected to the post of Vice-Chairman for the year 2021 – 2022.
