Minutes of the Ordinary Meeting of Wendron Parish Council held on Monday March 13, 2023 at 7:30pm in Penmarth Methodist Schoolroom.

1 APOLOGIES FOR ABSENCE

3 CONFIRMATION OF THE MINUTES OF THE LAST MEETING

Cllr Durkin proposed, Cllr Mrs Borman seconded and it was agreed that the minutes of the Meeting held on February 13, 2023 are a true record and the Chairman signed them as such.

4 MATTERS ARISING AND NOT COVERED ELSEWHERE IN THIS AGENDA

There were no matters arising.

5 CORNWALL COUNCILLOR'S COMMENTS

CCllr Dr Jenkin reported that

- the Alternative Fuel Payment for residents living off the gas grid is now being paid as a credit on their electricity bills
- she had attended a recent coffee morning in Penmarth and had fielded both a number of grumbles about the speed of traffic passing through the village and a suggestion that removable bollards might be deployed whenever there is an event being held in the village. PCSO Julia Berry had also been present at the coffee morning: she had agreed that through traffic as a whole is going too quickly and undertook to ask for a police speed monitoring unit to attend
- she wondered quite what was happening about the path along the causeway. The Clerk undertook to contact Rupert Spencer about this
- the 20's Plenty scheme is slowly being rolled out across Cornwall: it is scheduled to reach the parish of Wendron in 2025 at the earliest
- the decision concerning the parish boundary between the Park an Daras estate and Helston has been made and is to maintain the status quo
- an on-line Leats Meeting, attended solely by Cornwall Councillors, had noted that Parish Representatives need to be involved again, that Brian Skinner is now leading the initiative and that volunteers need to be co-ordinated under the umbrella of the Cormac Volunteer Scheme.

6 PUBLIC PARTICIPATION

As the applicants' agent, Mr Green sought the Council's support for PA23/01239 stating that his clients simply sought permission to continue with the development without compliance with condition 9 (PA11/03413) which requires development to be carried out in accordance with the submitted plans.

Mrs McShane stated that she sought support for her and her husband's application PA23/01673. She criticised comments made by individual councillors concerning this application at last month's meeting, but added that, in line with what had been suggested at that meeting, the submitted plan now shows the pump box on the other side of the property and away from neighbours fronting the road.

7 PARISH COUNCIL MATTERS

Co-option of members

The Clerk reported that no further expressions of interest in co-option as a Parish Councillor have been received.

8 PARISH MATTERS

Publicity

Cllr Durkin reported that, in the last month, four new FaceBook posts had attracted 331 views, the most popular being an advertisement for special constables.

The Neighbourhood Development Plan

The Clerk reported that, as requested, he had contacted Carn Brea Parish Council concerning the employment of a paid Neighbourhood Development Plan consultant. He understood that Carn Brea had employed Mr Besford-Foster to compile its Neighbourhood Development Plan. He had contacted Mr Besford-Foster to enquire whether or not he would be interested in doing the same for Wendron and Mr Besford-Foster has indicated that he is. Cllr Mrs Borman undertook to liaise with Cllr Ferris and to contact Mr Besford-Foster.

Public Rights of Way

Members considered an invitation from Cornwall Council to continue with the Local Maintenance Partnership scheme. The grant offered for the year to March 31, 2022 is £7,074.00 (or 100% of eligible costs, whichever is the lower). Cllr Durkin proposed, Cllr Law seconded and it was agreed that Wendron Parish Council should accept Cornwall Council's invitation to renew partnership working.

It was noted that PROW 157 which passes Tyack's Shaft is very wet. The Clerk undertook to contact the National Trust with a view to some maintenance work being undertaken.

Park an Daras

Members considered a proposal from a resident (who is concerned about waste littering the Park an Daras estate and, in particular, inconsiderate dog-walkers) to site a waste bin within the estate in an attempt to alleviate the problem. The Chairman proposed, Cllr Law seconded and it was agreed to contact the resident with a view to identifying a suitable spot and to underwrite the cost of a new bin, its siting and subsequent related collection costs.

The Coronation of HM King Charles III (Saturday May 6, 2023)

The Clerk reported that he has taken delivery of 216 commemorative mugs from Chown China for presentation to children currently attending Wendron and Halwin Schools together with primary-school aged children being educated at home as a way of celebrating the occasion of the coronation of HM King Charles III.

Members noted that Porkellis Church will be hosting a Big Lunch

CC 2023 Off-Street Parking Order – invitation to comment on the proposals – the Council understands that it is a difficult act to balance the requirements to raise revenue and to encourage greater use of public transport against the penalising of rural residents and the risk to shops in town centres of fewer customers, but that it believes that the proposals are too broad brush in nature.
